The Court has implemented a new procedure for scheduling settlement conferences. Court Administration has provided the following information:

All cases scheduled for a civil jury trial will be scheduled for a settlement conference. Three settlement masters have been appointed by the Court: Honorable Robert A. Freedberg, Honorable Emil A. Giordano, and Honorable Leonard N. Zito.

Settlement conferences will proceed as follows:

- 1. Judge Koury will assign a settlement master.
- 2. The settlement master's assistant will contact counsel to schedule the date and time of the settlement conference. An Order will be filed and e-mailed to counsel by Court Administration confirming the settlement conference.
- 3. The Order scheduling the settlement conference will set deadlines and procedures for submission of the settlement conference memorandum and supporting exhibits.
- 4. Counsel are not permitted to request a specific settlement master.
- 5. Only the President Judge has the authority to excuse attendance of the adjuster or trial counsel from the settlement conference. If a request is being made by the adjuster to be excused from attending the settlement conference, trial counsel must prepare and submit to the President Judge a Motion for Excusal of Attendance. This can be submitted to Court Administration by e-mail and does not need to be presented in person.

6. Initial requests for a continuance of a settlement conference should be made to the assigned settlement master. An Application for Continuance is not necessary. Once the conference has been rescheduled, a new scheduling Order will not be entered.

# MARIA PADULA-LARSON, Plaintiff v. JOSEPH PADULA, Defendant

Partition—Resulting Trust.

Plaintiff filed a complaint seeking partition of multiple parcels of real estate. Plaintiff and Defendant are siblings and co-beneficiaries of a trust established by their mother. The Court granted partition of the properties that were indisputably owned by Plaintiff and Defendant as tenants in common. However, Defendant disputed that Plaintiff maintained an ownership interest in one of the properties that she sought to partition. Plaintiff claimed an equitable interest in the property in the form of a purchase-money resulting trust.

The Court denied partition of the property in dispute, finding that Plaintiff did not establish the required elements of a purchase-money resulting trust with clear and convincing evidence. The Court determined that Plaintiff did not contribute to the purchase price of the property because, although the funds used to purchase the property were taken from the parties' trust, Plaintiff did not maintain an interest in the money once Defendant withdrew it for his personal use. The Court also determined that even if Plaintiff did maintain an interest in the funds, a resulting trust did not arise because Plaintiff did not intend for the money to be used by Defendant to purchase the property for Plaintiff and Defendant as tenants in common.

#### **DECISION**

This matter is before the Court on Plaintiff's "Second Amended Complaint in Partition," filed on August 6, 2015, and Defendant's Counterclaim, filed on October 30, 2015. In the Second Amended Complaint, Plaintiff seeks the partition of multiple parcels of real estate. A trial without a jury was held before the undersigned on March 12, 2018.

## FINDINGS OF FACT

- 1. Plaintiff and Defendant are siblings. (N.T., 03/12/2018, at 23:16-18.)
- 2. Plaintiff and Defendant are co-beneficiaries of a trust (the "Trust") established several years ago by their mother, Mary Padula. (*Id.* at 24:11-16, 25:7-9.)
- 3. Plaintiff is the trustee of the Trust, which contained a principal of 1.3 million dollars when it was created. (*Id.* at 25:2-6, 25:17-26:5.)

- 4. Plaintiff withdrew funds from the Trust to purchase real property located at 103 West Madison Street, Easton, Northampton County, which Plaintiff and Defendant own as tenants in common ("Parcel A"). (*Id.* at 27:17-20; Second Am. Compl. ¶3, Ex. A.)
- 5. Plaintiff also withdrew funds from the Trust to purchase real property located at 116 Bangor Street, Bangor, Northampton County, which Plaintiff and Defendant also own as tenants in common ("Parcel C"). (N.T., 03/12/2018, at 28:13-25; Second Am. Compl. ¶3, Ex. C.)
- 6. Plaintiff and Defendant agree that they wish to dissolve their partnership in relation to the benefits received from their joint ownership interests in Parcels A and C. (N.T., 03/12/2018, at 8:16-21.)
- 7. Defendant owns real estate located at 6555 Sullivan Trail, Pen Argyl, Northampton County ("Parcel E").<sup>2</sup> (Second Am. Compl. ¶5, Ex. D.)
- 8. The deed to Parcel E indicates that Defendant is the sole owner, and Plaintiff's name does not appear on the deed. (*Id.* Ex. D.)
- 9. Plaintiff claims equitable title to Parcel E in the form of a resulting trust and asks the Court to partition Parcel E. (Second Am. Compl. ¶¶6-8.)
- 10. Prior to Defendant's purchase of Parcel E, Plaintiff withdrew \$200,000.00 from the Trust and distributed it to Defendant. (N.T., 03/12/2018, at 41:22-42:4, 45:22-46:11.)
- 11. Plaintiff did not distribute the \$200,000.00 to Defendant with the intent that the pair would then use it to purchase Parcel E as tenants in common. (*Id.* at 42:5-9.)
- 12. Rather, Plaintiff's purpose in providing Defendant with the \$200,000.00 was to balance out her own previous \$150,000.00 withdrawal from the Trust to pay for an addition to her home. (*Id.* at 30:20-22, 46:1-19.)
- 13. Defendant used the \$200,000.00 distribution from the Trust to purchase Parcel E. (*Id.* at 29:1-13.)
- 14. Plaintiff was not involved in the purchase of Parcel E, and she was not aware of the purchase until after the fact. (*Id.* at 43:16-44:8.)

## CONCLUSIONS OF LAW

- 1. "Partition is a possessory action," and its purpose and effect is to give each joint owner of real estate possession of the share he or she is entitled to. *Lombardo v. DeMarco*, 350 Pa. Super. 490, 499, 504 A.2d 1256, 1260 (1985).
- 2. A tenant in common has an absolute right to partition of property owned by tenants in common. *Id*.

- 3. Partition can be refused "where the rules of civil procedure are not followed, where the parties are not all before the court, where the legal title to the land is unclear, where the interests of each party cannot be determined, where there was a waiver of, or an agreement concerning the right to partition, or where a decree in partition would violate public policy." *Id.* at 500, 504 A.2d at 1261.
- 4. "If the court determines that there shall be partition ... after a ... trial, the court shall enter an order directing partition which shall set forth the names of all the co-tenants and the nature and extent of their interests in the property." Pa. R.C.P. No. 1557.
- 5. Plaintiff and Defendant own Parcels A and C as tenants in common, and there are no reasons present that would warrant a refusal of Plaintiff's request to partition those parcels.
- 6. With regard to Parcel E, "[a] resulting trust arises when a person makes a disposition of property under circumstances which raise an inference that he does not intend that the person taking or holding the property should have a beneficial interest in the property." *Fenderson v. Fenderson*, 454 Pa. Super. 412, 422, 685 A.2d 600, 604 (1996).
- 7. "A purchase-money resulting trust arises in favor of the person who paid the purchase price, when the transfer of property is made to one person and the purchase price is paid by another." *Id*.
- 8. "In order for a purchase-money resulting trust to arise, the following is required: (1) the transfer is made to one person and the purchase price is paid by another; (2) the payor does not have the intention that no resulting trust shall arise; (3) the transferee is not the natural object of the transferor's bounty." *Id.* at 422, 685 A.2d at 604-605.
- 9. If more than one person contributes to the purchase price, "a resulting trust [can] arise[] in favor of the person who paid the purchase price in the proportion that the amount paid bears to the total purchase price." *Id.* at 422, 685 A.2d at 605.
- 10. "The law requires clear, direct, precise and convincing evidence of a resulting trust before it will convert absolute ownership in an estate of lesser quality." *Id.* at 423, 685 A.2d at 605.
- 11. "A prima facie case established by the party seeking a resulting trust can be rebutted by evidence showing that the payor did not intend to receive a resulting trust or any beneficial interest in the land." *Id.* at 424, 685 A.2d at 605.
- 12. With regard to Parcel E, Plaintiff has not proven the required elements of a resulting trust by clear and convincing evidence.
- 13. Plaintiff did not pay any of the purchase price for Parcel E because Plaintiff relinquished her beneficiary interest in the \$200,000.00 once it was withdrawn from the Trust and distributed to Defendant, for his personal use, to offset Plaintiff's previous withdrawal from the Trust in a similar amount.

- 14. Even if Plaintiff maintained an interest in the \$200,000.00, a resulting trust did not arise because Plaintiff did not intend that the money would be used by Defendant to purchase Parcel E for Plaintiff and Defendant as tenants in common.
- 15. Therefore, Plaintiff has no ownership interest in Parcel E and, as a result, is not entitled to a partition of Parcel E.

WHEREFORE, the Court enters the following:

## **ORDER**

AND NOW, this 20th day of March, 2018, the court hereby orders partition of the real property located at 103 West Madison Street, Easton, Northampton County, which Plaintiff Maria Padula-Larson and Defendant Joseph Padula each own one-half of as tenants in common.

The court hereby orders partition of the real property located at 116 Bangor Street, Bangor, Northampton County, which Plaintiff Maria Padula-Larson and Defendant Joseph Padula each own one-half of as tenants in common.

Plaintiff's claim for partition of the real property located at 6555 Sullivan Trail, Pen Argyl, Northampton County, is hereby DENIED, as Plaintiff has no ownership interest in that property.

The Court Administrator shall place this case on the April 20, 2018, miscellaneous hearing list for a preliminary partition conference, pursuant to Pennsylvania Rule of Civil Procedure 1558(a). The parties shall appear at the call of the miscellaneous hearing list on that day, in Courtroom Number One at 9:00 a.m.
