APPOINTMENT OF NEW MEMBERS TO THE PENNSYLVANIA JUDICIAL CONDUCT BOARD

The Judicial Conduct Board of Pennsylvania is pleased to announce that Governor Tom Wolf has recently appointed three new members to the Board: Judge Nina Wright Padilla of the Philadelphia Court of Common Pleas, Mandi L. Culhane, Esquire, of Allegheny County, and Mr. Michael P. Martin of Erie County.

The Judicial Conduct Board is an independent body of Pennsylvania citizens comprised of three judges, three lawyers and six non-lawyer, lay members. Half of the Board members are appointed by the Governor and half by the Pennsylvania Supreme Court. The Board's members serve four-year terms, without pay. No more than half of its appointed members may be from the same political party.

Judge Padilla has served on the Court of Common Pleas since 2003. She currently sits in the Civil Trial Division, Motions and Statutory Appeals Program. In addition, she also presides over Class Actions and Conservatorships, and is frequently assigned to Election Court. Judge Padilla sat in Philadelphia Family Court, Domestic Relations Branch from August 2003 until June of 2012 where she presided over matters of Divorce, Support, Custody, Domestic Violence and Criminal Abuse. In June 2012, she was reassigned to the Criminal Trial Division where she presided over criminal jury trials.

Throughout her tenure on the bench, she has continually served as a panelist in numerous continuing legal education programs, including programs for the Pennsylvania Bar Institute, the Philadelphia Bar Association and the Hispanic Bar Association of Pennsylvania. Judge Padilla currently serves as Committee Chair of the Board of View and Board of Revision of Taxes Committee for the Court of Common Pleas Board of Judges.

Prior to her judicial tenure, Judge Padilla maintained a private law practice with her husband, Edward C. Wright, who is presently a Judge assigned to the Civil Trial Division of the Philadelphia County Court of Common Pleas. While engaged in private law practice for ten years, her area of

concentration was Consumer Bankruptcy, as well as general civil litigation and criminal law. Throughout her years in private practice, Judge Padilla served as a legal analyst on both the Greater Media and Comcast Cable Programs, "Today's Law" and "Legaline."

Judge Padilla obtained her Juris Doctor from the University of Maryland School of Law, and her Bachelor of Science Degree from the University of Maryland, College Park.

Judge Padilla was appointed to fill the unexpired term of then-Common Pleas Court Judge Christine Fizzano Cannon who resigned her Board seat in 2017 when she was a candidate for the Commonwealth Court. Judge Padilla's term will run until October 30, 2018. At that time, the Governor may reappoint her for the balance of a four-year term. Under the Constitution, Board Members may not serve more than four consecutive years. Judge Padilla serves as the Common Pleas Court Judge Member of the Board.

Mrs. Culhane is a shareholder at the law firm of Goehring, Rutter & Boehm, with offices in Pittsburgh and Philadelphia. She practices within the firm's Municipal, Municipal Creditors' Rights, Real Estate and Litigation Groups.

She is admitted to practice before the United States Supreme Court, the United States Court of Appeals for the Third Circuit, the United States District Courts for the Western and Middle Districts of Pennsylvania, the Supreme, Superior and Commonwealth Courts of Pennsylvania and the Supreme Court of Appeals and Circuit Courts of West Virginia.

Mrs. Culhane is a member of the Allegheny County, Pennsylvania and American Bar Associations. She joined the Allegheny County Bar Foundation Fellows Class in 2010 and participated in the Allegheny County Bar Foundation Young Lawyers' Division Bar Leadership Initiative Class in 2007-2008. Since 2010, she has been repeatedly recognized as a Pennsylvania *Super Lawyer* Rising Star for her work in the areas of appellate practice and municipal law.

Mrs. Culhane graduated from Bucknell University in 2001, earning her B.A., *magna cum laude*. She graduated

Mr. Martin is President and owner of Printing Concepts Inc., a sheet-fed commercial printing company employing 34 people in Erie, a company widely recognized as the region's leader in print and direct mail services.

Among his professional and personal affiliations, Mr. Martin serves as a member of the Northwest Bank Regional Advisory Board, the Erie Philharmonic Board of Governors, and the UPMC Hamot Board of Corporators. He is chair of the Millcreek Township Zoning and Hearing Board and Vice Chair of the Erie Metropolitan Transit Authority. He previously served on the Erie County Redevelopment Authority, the First National Bank Advisory Board, the Erie Regional Chamber and Growth Partnership, and was one of the founding members of the Erie Runners Club. Mr. Martin attended Edinboro University of Pennsylvania.

Mr. Martin was appointed to fill the Board seat previously occupied by Mr. Kenneth Lawrence of Montgomery County who resigned before the end of his four-year term. Mr. Martin's appointed term will expire on February 20, 2022. He serves as one of six non-lawyer electors or laypersons having membership on the Board.

Created by constitutional amendment in 1993, the Judicial Conduct Board of Pennsylvania is an independent board within the judicial branch of the Commonwealth's government responsible for reviewing, investigating, and, where warranted, prosecuting complaints of judicial misconduct. If the Board, by majority vote, decides that there is probable cause to believe that a judge engaged in misconduct, the Board may file a complaint in the Court of

Judicial Discipline where the Board must prove the charges against the judge by clear and convincing evidence. The Court of Judicial Discipline decides if the Board has sustained its burden of proof and decides the sanction to be imposed for any proven misconduct.

GEORGEANNA RAMOS, Plaintiff v. JAMES FRASCA and FEDERAL EXPRESS CORP., Defendants

Preliminary Objections—Punitive Damages—Motor Vehicle Accident.

Plaintiff filed a complaint alleging that Defendant James Frasca, an employee of Defendant Federal Express Corp. ("FedEx"), was driving a FedEx truck at a high rate of speed while using a handheld electronic tracking device when he crashed into Plaintiff's vehicle. Plaintiff sought punitive damages in her complaint.

Defendants filed preliminary objections, asserting that Plaintiff's claim for punitive damages should be stricken. The Court analogized the case to a previous case in Northampton County in which a request for punitive damages was not stricken when the complaint alleged that the defendant was driving at a high rate of speed while texting on a cell phone. In applying the same rationale as was applied in the previous case, the Court overruled Defendants' objections.

ORDER

AND NOW, this 5th day of August, 2016, "Defendants' Preliminary Objections to Plaintiff's First Amended Complaint" ("Preliminary Objections"), filed on April 11, 2016, are hereby OVERRULED. Defendants shall file an answer to Plaintiff's "First Amended Complaint in Civil Action" ("Amended Complaint") within twenty (20) days.

STATEMENT OF REASONS

This matter was submitted to the Court at Argument Court on July 26, 2016, for disposition on the parties' briefs. On March 24, 2016, Plaintiff filed an Amended Complaint in which she alleges the following facts. On March 4, 2014, Defendant James Frasca ("Frasca") was, while in the scope of his employment with Defendant Federal Express Corp. ("FedEx"), operating a vehicle owned by FedEx when he rear-ended the vehicle that Plaintiff was operating, causing her to suffer personal injuries. (Am. Compl. ¶¶ 4-7.) Plaintiff avers that FedEx uses an electronic and/or computer system to track package and delivery information. (*Id.* ¶¶13-14.) FedEx provides its drivers with electronic and/or computer devices that can access and interact with this system. (*Id.* ¶14.) According to Plaintiff, Frasca was using either a cell phone or some other type of electronic or computer device to access the FedEx tracking system at the time he rear-ended her. (*Id.* ¶24.) In Count III of the Amended Complaint, Plaintiff seeks punitive damages.

In their Preliminary Objections, Defendants purport to assert a demurrer to Plaintiff's claim for punitive damages and assert that Plaintiff's allegations that Frasca drove in a "careless manner" should be stricken from the Amended Complaint. (See Am. Compl. ¶9(g), 11(g).) On April 11, 2016, Defendants filed their Brief. On May 24, 2016, Plaintiff filed a Brief in opposition to the Preliminary Objections. The next day, Plaintiff filed a Response to the Preliminary Objections. On June 13, 2016, Defendants filed a Reply Brief.

Defendants' Reply Brief contains several irregularities that should be addressed. First, Defendants assert that after filing their Preliminary Objections, they allowed "the lapse of the thirty[-]day response period as per the Rules of Civil Procedure" before filing their Praecipe for Argument on May 19, 2016. (Reply Br. 1.) Defendants go on to argue that Plaintiff's Response "is untimely per Local Rule 1028(c)," and, thus, the Court should "reject it in total and grant the Preliminary Objections." (*Id.*)

The Court notes that "no pleading need be filed unless the preceding pleading ... is endorsed with a notice to plead." Pa. R.C.P. No. 1026(a). Defendants' Preliminary Objections were not endorsed with a notice to plead. Thus, Plaintiff was not required to file a response to the Preliminary Objections. Nevertheless, even if the Preliminary Objections had been endorsed with a notice to plead, Plaintiff would not have been required to file a response because "preliminary objections raising an issue under ... [Rule 1028](a)(2) ... or (4) may be determined from facts of record so that further evidence is not required." Id. No. 1028(b) Note. Moreover, assuming the "lapse of the thirty[-]day response period" refers to the time in which Plaintiff could have responded to the Preliminary Objections by filing a second amended complaint, as of course, such a complaint would be due in twenty, rather than thirty, days. Id. No. 1028(c)(1). Finally, while Defendants claim that Plaintiff violated Northampton County Rule of Civil Procedure 1028(c), it is actually the other way around, given that Defendants filed their Praecipe for Argument more than twenty days after filing their Preliminary Objections. See Local Rule N1028(c)(1).

The second irregularity with regard to Defendants' Reply Brief is its assertion that "[t]here is nothing in the underlying factual investigation, *i.e.* police report, that the Defendant driver was a 'distracted driver' at any material time." (Reply Br. 2.) The Court is required to determine preliminary objections brought under Rule 1028(a)(2) solely from the allegations in the complaint, without any reference to outside facts or evidence, as such objections raise pure issues of law, not issues of fact. *Cf. Wimble v. Parx Casino and Greenwood Gaming & Entertainment, Inc.*, 40 A.3d 174, 179 (Pa. Super. 2012). Thus, Defendants are not permitted to inject new facts into the case via their Reply Brief, and the Court will not consider any such facts. Instead, any such facts must be averred as new matter in a pleading responsive to the Amended Complaint. *See* Pa. R.C.P. No. 1030(a).

Those irregularities having been examined, the Court turns to the next irregularity, Count III of Plaintiff's Amended Complaint. A request for punitive damages is not an independent cause of action to be pleaded in a separate count of a complaint. See Shanks v. Alderson, 399 Pa. Super. 485, 489, 582 A.2d 883, 885 (1990). This is because punitive damages are an element of damages arising out of a cause of action and, therefore, cannot be a cause of action standing alone. Kirkbride v. Lisbon Contractors, Inc., 521 Pa. 97, 101, 555 A.2d 800, 802 (1989). Nevertheless, Defendants have not raised a preliminary objection to Plaintiff pleading punitive damages as a separate count. Further, no purpose would be served by requiring Plaintiff to file a second amended complaint to plead punitive damages as an element of damages in Counts I and II of the Amended Complaint. Accordingly, Count III of Plaintiff's Amended Complaint will be addressed, at trial, as an element of damages sought for the causes of action asserted in Counts I and II of the Amended Complaint.

With regard to Defendants' demurrers to Plaintiff's request for punitive damages, the Court notes that "[p]reliminary objections in the nature of a demurrer are an inappropriate means by which to challenge the legality of the damages sought in a complaint." See Hudock v. Donegal Mutual Insurance Company, 438 Pa. 272, 277 n.2, 264 A.2d 668, 671 n.2 (1970). As the Pennsylvania Supreme Court explained in Hudock, "[t]his rule is a sound one because a plaintiff should not be put out of court completely merely because he alleges the wrong measure of damages." Id. In Hudock, the court treated the defendant's demurrer to, inter alia, the plaintiff's claims for punitive damages, as a preliminary objection alleging "inclusion of ... impertinent matter," pursuant to Rule of Civil Procedure 1028(a)(2). Id. Accordingly, the Court will treat Defendants' demurrers to Plaintiff's request for punitive damages in the same manner.

To be impertinent, "the allegations must be immaterial and inappropriate to the proof of the cause of action." *Common Cause/Pennsylvania v. Commonwealth*, 710 A.2d 108, 115 (Pa. Commw. 1998).

In Pennsylvania, 'punitive damages are awarded for outrageous conduct, that is, for acts done with a bad motive or with a reckless indifferen[ce] to the interests of others.' Judge Technical Servs., Inc. v. Clancy, 813 A.2d 879, 889 (Pa.Super.2002) (emphasis and internal quotation marks omitted). '[P]unitive damages are penal in nature and are proper only in cases where the defendant's actions are so outrageous as to demonstrate willful, wanton or reckless conduct.' Empire Trucking, 71 A.3d at 937 (quoting Hutchison v. Luddy, 582 Pa. 114, 870 A.2d 766, 770 (2005)). 'The state of mind of the actor is vital. The act, or the failure to act, must be intentional, reckless or malicious.' Hutchison, 870 A.2d at 770.

Sears, Roebuck & Co. v. 69th Street Retail Mall, L.P., 126 A.3d 959, 983 (Pa. Super. 2015) (second alteration in original). For purposes of awarding

punitive damages, Pennsylvania law requires a specific type of recklessness defined in comment *a* to Section 500 of the Restatement (Second) of Torts. *Hutchison v. Luddy,* 582 Pa. 114, 122, 870 A.2d 766, 771 (2005). Under that definition, a person acts with recklessness where he "knows, or has reason to know, ... of facts which create a high degree of risk of physical harm to another, and deliberately proceeds to act, or to fail to act, in conscious disregard of, or indifference to, that risk[.]" *Id.* at 122-23, 870 A.2d at 771, (quoting *Martin*, 494 A.2d at 1097). Therefore, "a punitive damages claim must be supported by evidence sufficient to establish that (1) a defendant had a subjective appreciation of the risk of harm to which the plaintiff was exposed and that (2) he acted, or failed to act, as the case may be, in conscious disregard of that risk." *Id.* at 124, 870 A.2d at 772.

This Court has previously ruled on the issue of whether a plaintiff may request punitive damages when the defendant is alleged to have been talking on a cell phone while driving. See Xander v. Kiss, No. CV-2010-11945, 2012 WL 168326 (C.P. of Northampton Cnty. Jan. 11, 2012). In Xander, the Honorable Leonard N. Zito held that allegations that the defendant lost control of his vehicle while speaking on a cell phone were, on their own, insufficient to sustain a request for punitive damages, especially without any "additional indicators of gross negligence or reckless disregard for the rights of others." Xander, id. at *1.

However, the instant case is distinguishable from *Xander* because the allegation here seems to be that Frasca was actively *using* and *looking at* an electronic device while driving. (*See* Am. Compl. ¶14, 24.) Rather than talking on a cell phone, this conduct is more in line with texting on a cell phone, an activity that requires a driver to be reading a text message on the phone's screen or typing a text message using a keyboard or screen on the phone. Thus, the Court equates the allegations here with allegations that a driver was texting while driving. *See Rockwell v. Knott,* 32 D. & C.5th 157, No. 12 CV 1114, 2013 WL 10215759, at *8 (C.P. of Lackawanna Cnty. Aug. 13, 2013) ("Texting while driving significantly increases the degree of driver distraction since it requires the motorist to completely divert his or her attention from the roadway as [s]he focuses upon the mobile device. As such, texting poses a much greater risk to pedestrians and other motorists than speaking on a cell phone.").

The undersigned has previously held, in a case involving allegations that the defendant was texting while driving, that "receiving or sending a text message requires the driver to look away from the road for what can be a critical period of time. While texting alone may not warrant an award of punitive damages in any given case, ... texting while operating [a vehicle] 'at a high and excessive rate of speed'" may. *Werner v. Zeruth*, C-48-CV-2013-2349, slip. op. (C.P. of Northampton Cnty. Dec. 2, 2013) (quoting the plaintiff's complaint). In this case, Plaintiff alleges that Frasca was operating his vehicle "at a speed which was too fast in order to stop before the collision with Plaintiff's vehicle." (Am. Compl. ¶23.)

At this early stage of the case, the parties have not yet had the chance to engage in discovery to determine whether evidence exists to substantiate Plaintiff's allegations. While it is true that "the [C]ourt must determine whether the plaintiff has presented sufficient evidence to support a punitive damage award before submitting the issue of such damages to the jury," the Court can only perform this function once discovery is complete and a motion for summary judgment has been filed. *Doe v. Wyoming Valley Health Care System, Inc.*, 987 A.2d 758, 768 (Pa. Super. 2009). Given the abovementioned facts, the Court cannot determine that punitive damages are impertinent to Plaintiff's causes of action at this stage of the proceeding. Accordingly, Defendants' objection to Plaintiff's request for punitive damages must be overruled.¹

Finally, as to Plaintiff's allegations that Frasca drove "in a careless manner in violation of Section 3714 of the Motor Vehicle Code," "[t]he language 'careless disregard,' as used in th[at] statute, set the level of culpability of the statutory offense at less than willful and wanton conduct, but more than ordinary negligence or the mere absence of care under the circumstances." *Commonwealth v. Cathey,* 435 Pa. Super. 162, 164, 645 A.2d 250, 250 (1994). In this case, Plaintiff must prove something "more than ordinary negligence" in order to prevail in her request for punitive damages. For that reason, the allegations of careless driving, as defined in the Vehicle Code, are not impertinent to her causes of action, and Defendants' objection to those allegations must likewise be overruled.

¹ Of course, this ruling is without prejudice to Defendants to move for summary judgment if Plaintiff is unable to establish these facts during discovery.
