(d) Have been engaged in the active practice of law for a period of at least five years. The Judicial Council may consider other suitable legal experience as a substitute for the active practice of law.

The selection process will be confidential and competitive. The current annual salary is \$160,080. Persons shall be considered without regard to race, color, age, gender, religion, national origin, disability or religious affiliation. The name of the candidate selected for the position will be published for public comment prior to appointment. The
