### **Description of Decision:**

Plaintiffs filed a complaint asserting, *inter alia*, a claim against Defendants pursuant to the Unfair Trade Practices and Consumer Protection Law ("UTPCPL"). Plaintiffs alleged that Defendants, when they leased a residential property to Plaintiffs, knowingly misrepresented that there were two working fireplaces in the residence when only one of the fireplaces worked properly. Plaintiffs alleged that they suffered damages by paying for a rental property with two working fireplaces when, in fact, the property had one; by incurring increased heating charges; and by suffering a loss of use and enjoyment of the residence due to the non-functioning fireplace.

Defendants filed preliminary objections, alleging that Plaintiffs' complaint is legally insufficient because it does not plead that Plaintiffs suffered "ascertainable loss" pursuant to the UTPCPL and because it does not plead that Plaintiffs relied on Defendants' representations. The Court held that, given that the UTPCPL is to be construed liberally, Plaintiffs sufficiently pleaded "ascertainable loss." The Court further held that, since Plaintiffs pleaded that they suffered damages as a result of Defendants' misrepresentations, Plaintiffs sufficiently pleaded that they relied on those misrepresentations.

### **Description of Decision:**

Plaintiff, a police officer formerly employed by Defendant, filed a complaint alleging that Defendant wrongfully terminated his employment by not providing him with notice and a hearing prior to termination. Plaintiff raised his allegations pursuant to the Police Tenure Act, the Local Agency Law, and Section 1983 of the Civil Rights Act of 1871. Defendant filed preliminary objections, asserting, *inter alia*, a demurrer to all counts in the complaint and asserting an objection based upon the pendency of a prior action.

In a prior case arising out of Plaintiff's firing, the Court had determined that the Police Tenure Act did not apply to Defendant's police force at the time Plaintiff was fired. At oral argument on the instant preliminary objections, Plaintiff's counsel expressed agreement with the Court's reasoning in its prior decision and, therefore, the Court

sustained the demurrer with respect to the Police Tenure Act. The Court also sustained Defendant's demurrer to Plaintiff's Local Agency Law claim. Since the Local Agency Law only requires that an employee be afforded notice and a hearing prior to termination if the employee has a personal or property right in continued employment, and since Plaintiff was an at-will employee, the Local Agency Law did not apply to him. For the same reasons that it sustained Defendant's demurrer to Plaintiff's Local Agency Law claim, the Court also sustained Defendant's demurrer to Plaintiff's Section 1983 claim alleging a deprivation of property without due process. Since Plaintiff was an at-will employee, he had no property interest in his continued employment with Defendant. However, the Court overruled Defendant's objection to Plaintiff's Section 1983 claim alleging a deprivation of liberty without due process. Since a public employee who is defamed in the course of his termination can bring a Section 1983 deprivation of liberty claim even without a property interest in his employment, and since Plaintiff pleaded that he was defamed in the course of his termination, the Court held that he had pleaded a valid claim pursuant to Section 1983.

Finally, the Court overruled as moot Defendant's objection asserting pendency of a prior action since the Court had quashed Plaintiff's appeal in the prior action before argument on the instant preliminary objections.

The Court had denied Defendant's motion for summary judgment upon an assertion of immunity from suit under the co-employee exception of the Workers' Compensation Act upon a finding that the exception only applied to natural persons. Defendant filed a motion for reconsideration alleging two points of error: (1) that the Court had impermissibly considered a late supplemental brief filed by Plaintiff contra the summary judgment motion and (2) the Court had erred in concluding that Defendant was not immune from suit under the co-employee exception. The applicability of the exception, Defendant further asserted, was mandated by the form of the Complaint which alleged that Defendant had acted through its employees. Upon consideration, the Court rejected Defendant's argument with regard to the late brief upon the findings that (1) it was well within the Court's discretion to accept the late brief; (2) Plaintiff had substantially complied with the local procedural rules; (3) Defendant was not prejudiced; and (4) the Court would have come to the same conclusion even without considering the brief. As to the applicability of the co-employee provision, the Court reviewed the matter and came to the same conclusion it had in ruling on the summary judgment motion, based upon the clear and unequivocal language of the Act.
