License Suspension—Habitual Offender's Provision—Juvenile Consent Decree

Order of Court entered granting Petitioner's license revocation appeal permitting Petitioner to appeal *nunc pro tunc*.

DESCRIPTION OF DECISION

Petitioner appealed the five-year suspension of his driver's license, arguing that his suspension does not qualify under the Habitual Offender's provision, 75 Pa.C.S. §1542. Under the provision, three prior DUI convictions are required. Petitioner argues that although he has three prior convictions, one was culminated in a juvenile consent decree which is not included as an offense in the above provision. Therefore, Petitioner argues that his untimely filed appeal should not be barred because DOT had no authority to revoke his license initially.

The Court found that although appeals *nunc pro tunc* are usually only granted where the appeal was untimely due to fraud or a breakdown in the court's operations, this standard has been relaxed in extraordinary circumstances. The Court found that DOT had no authority to suspend Petitioner's license, and therefore, allowed the appeal *nunc pro tunc* due to Petitioner's extraordinary circumstances.

DESCRIPTION OF DECISION

Petitioner filed a Petition for Review as to the findings of the Bethlehem Township Civil Service Commission regarding his suspension and written reprimand from the Bethlehem Township Police Department. Petitioner objected to the findings of the Commission, claiming they were not supported by substantial evidence. He further argued that the penalty imposed upon him by the Township was arbitrary, discriminatory and/or an abuse of discretion.

The Court entered an order denying the Petitioner's Petition for Review and affirming the decision of the Civil Service Commission. The Court found that there was substantial evidence to support the findings of the Commission, that the punishment imposed was not excessive, nor was it arbitrary, discriminatory or an abuse of discretion. The Court further found Petitioner was insubordinate to his superiors, and punishment was warranted. Finally, the Court found that the punishment imposed upon Petitioner was not too temporally remote.

DESCRIPTION OF DECISION

Objector, Gunter Peter Senftleben, challenged the first and final accounting of the coexecutor, Donald C. Seagreaves, claiming the amount to be paid toward commission was arbitrary, unreasonable, and excessive in light of the time and labor involved, as well as the novelty and difficulty of the matters. Objector also argues that the amount is excessive because the majority of Decedent's assets were non-probate, and the co-executor failed to list the time required to perform his duties.

The Court found that the amount of commission charged was not arbitrary, unreasonable or excessive. It found that the co-executor did perform special services for the Decedent's estate which entitled him to additional compensation according to an agreement in the will and fee schedule. The Court found that the amount of compensation was fair and just in light of the services performed, and the time spent on performance, which the co-executor testified to. Therefore, the Court denied the Objection.

RICHARD FREDERICK SIMMERS v. SUSAN LEE SIMMERS, DECEASED

Preliminary Objections—Failure To Conform Pleadings—Pretrial Statement—Judge's Signature—Standing To Intervene

In the Court of Common Pleas of Northampton County, Pennsylvania, Civil Law Division, No. C0048CV2002-000807.

Order of Court entered granting in part and denying in part Defendant's Preliminary Objections.

Order of Court entered on October 22, 2003 by F.P. Kimberly McFadden, Judge.

DESCRIPTION OF DECISION

Petitioner filed Preliminary Objections to the petitions of Joseph J. Exley and Faye B. Exley, maternal grandparents (hereinafter "Respondents"), requesting that they be granted permission to intervene in this matter. Petitioner seeks to have the Respondents' pleadings dismissed and the Custody Complaint stricken. Petitioner argues that

the Respondents failed to conform to Pennsylvania Rule of Civil Procedure 1915.3(e), in that they neglected to plead in Paragraph 7 of the Custody Complaint, facts establishing the elements of a cause of action under §§5313(b)(1), (2) and (3). The Court found that the Respondents failed to sufficiently provide facts to support a cause of action pursuant to the three elements required. Therefore, Respondents were ordered to file an Amended Custody Complaint in accordance with Pa. R.C.P. 1915.3(e) and 1915.15(a).

Petitioner also filed Preliminary Objections, arguing that the required Pretrial Statement was not filed with the Court, and further that it requires the signature of the interveners, which was not provided. The Court found that the Pretrial Statement was filed by the Respondents on April 17, 2003. This Court further found that although the Pretrial Statement submitted on behalf of the Respondents was signed by their counsel, and not by the Respondents, the failure of the Respondents to sign does not constitute fatal error as to dismiss their Complaint. The Court ordered the Respondents to re-file the Pretrial Statement with the appropriate signatures.

Petitioner next argued that the Respondents failed to secure the Court's signature on an "Order of Court" requiring the Petitioner to appear for a custody conference. The Court found that this was in error and that the Order of Court must be signed by a judge.

Petitioner argued that the Respondents lack standing to intervene in this suit pursuant to 23 Pa. C.S.A. §5313(a) and (b). This Court found that Respondents have standing to petition for custody of the child in this case.

Finally, Petitioner argued that the Respondents failed to provide sufficient information to substantiate their claims under 23 Pa. C.S.A. §§5311 or 5313, and therefore their pleadings should be stricken. This Court found that it would be premature at this stage to address the substantive issues of whether it is in the child's best interests to grant the Respondents partial custody or visitation and/or physical and legal custody because the depositions provided from prior proceedings in New Hampshire were lacking in specificity toward the issues involved in the case at bar. Further, the Court found that it would be premature to decide the welfare of a child without first receiving the results from the psychological evaluation performed. Therefore, the Court ordered that this matter shall be heard on the non-jury list at which time all relevant additional evidence shall be presented.

ELLAMAE NIKODEN v. ALBERTA AND JAMES LOSEY

Preliminary Objections—Lack of Capacity To Sue—Standing—Failure To Attach Agreement of Sale—Failure To Aver with Particularity—Fraud

DESCRIPTION OF DECISION

Defendants raise Preliminary Objections arguing first that Plaintiff lacks a substantial, direct and immediate interest in the outcome of this matter as required by Pa. R.C.P. 1028(a)(5) because her interest as an heir at law in the property that is the subject

matter of this dispute is too remote. Plaintiff counters Defendants' argument, stating that she does have capacity to sue because she is the only daughter and sole heir of Frankenfield, and therefore has a substantial, direct and immediate interest in the outcome of this matter. The Court denied Defendants' Preliminary Objection, finding that Plaintiff does have a substantial, direct and immediate interest in the outcome of the litigation.

Defendants further raise Preliminary Objections arguing that Plaintiff's failure to attach an Agreement of Sale to the Complaint is fatal to the Complaint in violation of Pennsylvania Rule of Civil Procedure 1019(i) and therefore the Complaint lacks specificity and should be stricken. The Court found that the crux of Plaintiff's Complaint is based upon the Power of Attorney document, which has been attached to the Complaint. Plaintiff raises no cause of action based upon the Agreement of Sale itself and therefore, the Agreement of Sale need not be attached pursuant to Pa. R.C.P. 1019(i).

Finally, Defendants raise Preliminary Objections to the Plaintiff's averments of fraud in the Complaint arguing that Plaintiff failed to aver with particularity the allegations of fraud as required by Pa. R.C.P. 1019(b). The Court ruled that the averments in the referenced Paragraphs adequately explain the nature of the claim raised against them, so as to allow the Defendants to properly prepare a defense and found that the averments are more than mere subterfuge. Therefore, the Court denied the Defendants' Preliminary Objections.

DESCRIPTION OF DECISION

Defendants St. Luke's Hospital and St. Luke's Hospital and Health Network, filed Preliminary Objections in the form of a motion to strike paragraph 27 of Plaintiff's First Amended Complaint for general agency allegations in violation of Pennsylvania Rule of Civil Procedure 1019(a). Defendants further filed Preliminary Objections in the form of a motion to strike paragraph 27 and its subparagraphs, as well as the WHERE-FORE clause for failure to plead sufficient facts to support a claim for punitive damages.

The Court found that the general agency language in paragraph 27 failed to sufficiently identify those whom Plaintiff intended to hold accountable, failed to set forth the agent's authority and how the allegedly tortious acts fall within the scope of the agent's authority. Therefore, the Court granted Defendants' Preliminary Objection.

The Court further found that Plaintiff's claim for punitive damages lacked sufficient facts to support such a claim. The Court found that Plaintiff's allegations amounted to no more than a claim for gross negligence. Therefore, the Court granted Defendants' Preliminary Objection.

DESCRIPTION OF DECISION

Defendants PHI Aging and Health Care Services, Presbyterian Homes, Inc., Presbyterian Housing and Services Corporation and Kirkland Village filed a Preliminary Objection in the nature of a demurrer to Plaintiff's claim of negligence per se for violations of federal and state regulations. The Court found that while a Plaintiff cannot seek a private cause of action against Defendants, Restatement (Second) of Torts 286 allows a Plaintiff to assert a negligence per se claim if Plaintiff can establish that they were in the class the statute intended to protect. The Court found that Plaintiff's argument was sufficient at this stage to assert a claim for negligence per se, and therefore denied Defendants' Preliminary Objection.

Defendants also filed a Preliminary Objection in the nature of a demurrer to Plaintiff's claim of corporate negligence. They argued in the alternative, that if the Court finds merit to allow the corporate negligence allegation, Paragraph 17 and its designated subparagraphs should be stricken for lack of specificity. The Court found that, because the law does not specifically bar recovery on a corporate negligence theory, Plaintiff may sustain a cause of action for corporate negligence at this stage. In regard to the Defendants' alternative argument, the Court found that the language in Paragraph 17 and its designated subparagraphs were sufficiently argued for a corporate negligence claim as to the acts Defendants allegedly negligently committed. Therefore, the Court denied Defendants' Preliminary Objections.

Defendants further filed Preliminary Objections to the claim for punitive damages based on allegations of reckless and wanton conduct. The Court found that sufficient facts were put forth to support a claim for punitive damages for reckless conduct. Therefore, the Court denied Defendants' Preliminary Objections.
