DESCRIPTION OF DECISION

This matter was brought before the Court pursuant to the Petition for Involuntary Termination of Parental Rights submitted by Petitioners Adoptions From the Heart and John W. Rybak, Esquire, guardian ad litem of the minor child, Q.S. The Petitioners are seeking to terminate the parental rights of the biological mother, Desa'ree Spencer, and the biological father, Charles Scott.

The Court found that under both statutory sections addressed, the general needs and welfare of Q.S. will best be served by staying with the adoptive parents, Tammy and Eric Smeak. Therefore, this Court finds that the parental rights of both Father and Mother should be terminated.

DESCRIPTION OF DECISION

Defendant Richard A. Chaffier brought Motion for Summary Judgment arguing he is an out of possession landlord and had no control over the design or maintenance of the premises where Plaintiff was injured. Defendant Chaffier is the owner of the property, which he leased to Ice Slingers, Inc. t/a Rita's Italian Ices for a term of five (5) years.

The Complaint arose after Plaintiff drove to Rita's Italian Ices, walked up to Rita's window, placed an order, received her order and turned to begin walking back to her car. While walking, Plaintiff allegedly fell off the step-off of the concrete pad that sloped downward, fracturing her right ankle, right tibia and suffered generalized trauma requiring surgery, plates and screws.

Plaintiff argues that deposition testimony was not taken of Defendant Chaffier, and that summary judgment would be premature at this point. Pa. R.C.P. 1035.3 states that a court can rule that depositions be taken as is just. Therefore, this Court ruled that summary judgment would be premature at this point and granted 45 days leave for Plaintiff to take deposition testimony of Defendant Chaffier.

Defendants filed Preliminary Objections to Plaintiff's Complaint. Plaintiff responded by filing Preliminary Objections to Defendants' Preliminary Objections, arguing that Defendants' were untimely filed in violation of Pa.R.C.P. 1026(a). The Court found that although Defendants' were eight (8) days late in filing their Preliminary Objections, no prejudice nor any substantial rights of the parties would be affected by considering the substantive legal issues of the Defendants' Preliminary Objections and therefore, denied Plaintiff's Preliminary Objections.

Defendants filed a Preliminary Objection arguing that Plaintiff's Complaint failed to state a cognizable cause of action against Defendants Prass and Bauer. Plaintiff agreed with Defendants that Prass and Bauer should be dismissed from Counts I, II, IV, V and VI. Therefore, the Court ruled the above two Defendants dismissed from the above counts.

Defendants filed a Preliminary Objection for failure of Plaintiff to state in her Complaint whether the agreement she bases her claims on was written or oral. The Court found that Pa.R.C.P. 1019(h) requires the Complaint to specify oral or written. Therefore, the Plaintiff was granted twenty (20) days leave to amend her Complaint.

Defendants filed a Preliminary Objection for failure of Plaintiff to set forth the date of termination of Plaintiff in violation of Pa.R.C.P. 1019(a). Plaintiff claims Defendant has knowledge of this date and therefore need not specify it. The Court found that the fact that Defendant may be aware of the date does not relieve the Plaintiff, as pleader, from specifying the facts. DESCRIPTION OF DECISION

Plaintiffs brought action to quiet title in the nature of a complaint to compel satisfaction of a mortgage A dispute arose over the proper payoff amount of the mortgage after it was discovered that the amortization schedule prepared by Defendants' attorney was incorrect.

The Court found that when calculating the amount of interest on a mortgage note, it must look to the clear and unambiguous terms of the document to determine the intent of the parties. Further, interest on residential mortgages is customarily calculated on an annual basis, to be paid monthly. Reliance on amounts due on a mortgage should first be placed on the terms of the mortgage note, not the amortization schedule.

Defendants raise Preliminary Objections to Plaintiffs' claim for punitive damages arguing that the crux of Plaintiffs' claim lies in the alleged breach of a provision in the lease agreement, particularly, allegedly failing to repair a leaky roof, causing mold to accumulate and subsequent health problems to the Plaintiffs. Defendants argue that the Plaintiffs' causes of action arise out of an alleged breach of the contractual lease agreement, and therefore are based upon a breach of contract theory. This Court found that at this stage, the Plaintiffs have adequately set forth sufficient facts to go forward from this point with a claim for punitive damages. The Court noted that in order for the Plaintiffs to recover on the punitive damages claim, they must present a strong nexus between the mold accumulation and the subsequent medical problems complained of. Therefore, the Court denied the Preliminary Objection.

DESCRIPTION OF DECISION

Plaintiffs and Defendants Kline and Sharkan Supply Company seek the imposition of sanctions against Francis Elden Bauer and C.R. England, Inc. for failure to comply with the Court's discovery Order of July 3, 2003. The Court entered a directed verdict against Francis Elden Bauer on the issue of negligence because Bauer was illegally parked in a "no parking zone" in front of a stop sign in violation of 75 Pa. C.S.A. §3353(a)(2)(iv), which is negligence per se. The Court determined that a directed verdict was warranted for his failure to appear at a Court ordered deposition and failure to keep the court and his counsel notified of his present whereabouts.
