NORTHAMPTON COUNTY REPORTER DIGEST—2004-4 RECENT DECISIONS OF THE COURTS OF COMMON PLEAS OF NORTHAMPTON COUNTY

COMMONWEALTH OF PENNSYLVANIA v. MARTIN SHAMLIAN

P.C.R.A.

In the Court of Common Pleas of Northampton County, Pennsylvania, Criminal Division, No. 2001-1950.

Order of Court entered dismissing the P.C.R.A. Petition filed on behalf of the Defendant.

Order of Court entered on November 5, 2003 by Stephen G. Baratta, Judge.

DESCRIPTION OF DECISION

The Court dismissed the instant P.C.R.A. Petition because the Court found that totality of the circumstances indicated that Defendant understood the nature of the charges to which he pled guilty, that on numerous occasions he was apprised of the fact that the crime was rated as a misdemeanor of the second degree, and that he was aware of, but did not take advantage of, his right to withdraw his guilty plea prior to sentencing. Accordingly, the Court dismissed the Petition.

Request for Ejectment
