Bradford, 46 A.3d 693, 705 (Pa. 2012) (finding that the Commonwealth did not violate Rule 600 where the delay was caused by the Magisterial District Judge's failure to forward the file to the Court of Common Pleas as required by Pa.R.Crim.P. 547(B), resulting in the Court's failure to generate a docket number and, in turn, failure to trigger the District Attorney's internal tracking system; "[T]he Commonwealth exercised due diligence and the delay resulted from judicial delay beyond the Commonwealth's control.").

- 7. Civil jury trials previously scheduled for April 13, 2020 are continued to August 24, 2020.
- 8. Civil jury trials previously scheduled for May 11, 2020 are continued to September 21, 2020.
- 9. Civil non-jury trials previously scheduled for the week of April 27, 2020 are continued to the week of June 1, 2020. In lieu of a civil non-jury call, attorneys and parties shall send an email to the Office of Court Administration (jgreene@nccpa.org) by May 22, 2020, stating whether the matter is ready for trial and the approximate length of such trial.
- 10. The Sheriff sale previously scheduled for May 8, 2020 shall be continued until June 5, 2020.
- 11. Asbestos pretrial conferences scheduled for April 1, 2020 are continued until June 24, 2020 at 9:30 a.m. Asbestos pretrial conferences scheduled for April 29, 2020 are continued until July 22, 2020 at 9:30 a.m.
- 12. Time calculations for the purposes of time computation relevant to Northampton County local rules are suspended from April 14, 2020 to May 31, 2020.
- 13. The duration of an order appointing an Emergency Guardian of the person or estate of an incapacitated person pursuant to 20 Pa.C.S.A. § 5513 shall be extended from 72 hours to 45 days from date of issuance of the order. All orders appointing an Emergency Guardian of the person or estate of an incapacitated person pursuant to 20 Pa.C.S.A. § 5513 which were

- issued between March 18, 2020 and April 9, 2020 shall be extended until June 2, 2020.
- 14. The duration of an order granting a temporary *ex parte* Protection from Abuse petition and scheduling a final hearing pursuant to 23 Pa.C.S.A. § 6107(b) shall be extended such that the date of the hearing pursuant to 23 Pa.C.S.A. § 6107(a) shall be extended from 10 days to 45 days from the date of the issuance of the temporary order. All final hearings previously scheduled pursuant to 23 Pa.C.S.A. § 6107(a) for a date between April 14, 2020 and May 31, 2020 shall be continued until Friday, June 5, 2020. All orders granting a temporary *ex parte* Protection from Abuse petition shall be extended until June 5, 2020. The hearings shall be scheduled on June 5, 2020 at 30-minute intervals from 9:00 a.m. until 12:00 p.m. and from 1:30 p.m. until 3:30 p.m.
- 15. Complaints for child custody, petitions for modification or contempt of child custody orders, petitions for special relief in child custody, and stipulations concerning child custody shall be filed by mail to the Office of Court Administration, along with all required filing fees, related documents and a self-addressed, stamped envelope.
- 16. Except as set forth below, the Northampton County Court of Common Pleas shall remain **CLOSED TO THE PUBLIC** through May 31, 2020 at 4:30 p.m.
- 17. The Sheriff of Northampton County shall only allow entry to court facilities, which are under the direction and control of the President Judge, to members of the press, attorneys, parties, and witnesses for the proceedings set forth below.

TT

It is further **ORDERED** that Courtroom 9 of the Northampton County Courthouse shall remain open during Court business hours as an "Essential Services Court." The President Judge of the Northampton County Court of Common Pleas is assigned to solely preside over the Essential Services Court to handle all of the following proceedings:

- 1. guilty plea hearings for incarcerated defendants;
- 2. sentencing hearings for incarcerated defendants;
- 3. Gagnon I and Gagnon II hearings;
- 4. motions for bail modification for incarcerated defendants awaiting hearings for Gagnon II parole, probation, and intermediate punishment revocation hearings;
- 5. petition for parole hearings;
- 6. petitions for furlough;
- 7. applications for search warrants and arrest warrants;
- 8. bail modification and revocation hearings;
- 9. bench warrant hearings for criminal and domestic relations matters;
- 10. petitions for emergency guardian of the person or estate of an incapacitated person pursuant to 20 Pa.C.S.A. § 5513;
- 11. actions for emergency child protective services by the Northampton County Division of Children, Youth, and Families;
- 12. juvenile emergency shelter and detention hearings;
- 13. petitions for emergency child custody pursuant to Pa.R.C.P. 1915.4, where there is an immediate danger to the safety, health, or well-being of the child;
- 14. preliminary injunction proceedings where the moving party can establish a threat of irreparable harm, in which case, before appearing in Court, the moving party shall email a .pdf copy of the motion together with a memorandum of law in accordance with Northampton County Local Rule N210 to the Office of Court Administration (jgreene@nccpa.org), and thereafter, the Court Administrator will contact the parties and inform them whether the President Judge has approved an emergency hearing in the matter;
- 15. any pleading or motion relating to public health concerns and involving immediate and irreparable harm;
- 16. complaints and hearings for indirect criminal contempt of a protection from abuse order;

- 17. emergency petitions for protection from abuse;
- 18. emergency petitions for protection from elder abuse; and
- 19. emergency petitions for protection of victims of sexual violence or intimidation.

The hearings set forth in Section II (1)-(14) above may **only** be conducted via two-way simultaneous audio-visual communication with Courtroom 9 by using Polycom video conferencing or Skype for Business video conferencing. Members of the press may view the proceedings in Courtroom 9 or by using the Polycom RealPresence app for Android or Apple devices or by using Skype for Business.

## **Polycom Real Presence**

## **Skype for Business**

Judicial secretaries will schedule Skype for Business video conferences through the Microsoft Outlook email client. The judicial secretaries will email the meeting invitation to the hearing participants. At the scheduled time of the hearing, the participants will click on the "Join a Skype Meeting" link in their email client which will open a small web application connecting the participants to the meeting without the need to download an app on their devices.

III.

In order to limit the risk of exposure to Coronavirus (COVID-19) to the public, and pursuant to this Court's

Declaration of a judicial emergency in the Third Judicial District and the mandate of Pennsylvania Rule of Judicial Administration 1952(B)(2) to "take necessary action to provide for the ... safety of court personnel, court users and the public ...," except as set forth in Section III (3), (5), (7)-(9) below, it is hereby **ORDERED** as follows:

- 1. During the effective period of this Order, all court cases previously assigned to any other Judge of the Court of Common Pleas, or any of the administrative judges of any of the divisions of the Court of Common Pleas, shall be reassigned to the President Judge.
- 2. Unless specifically assigned by written Order of Court issued and filed by the President Judge, all other Judges of the Court of Common Pleas, and all administrative judges of any of the divisions of the Court of Common Pleas, shall not conduct any of the proceedings set forth in Section II above, and shall not conduct any other type of proceeding or hearing which requires parties or attorneys to appear in person in court.
- 3. Nothing in this Order prohibits a Judge from (1) issuing an order in a previously assigned case which was fully submitted prior to the date of this Order and does not require any parties or attorneys to appear in person in court; or (2) conducting a Gagnon II hearing only via the Polycom RealPresence app or Skype for Business, specially scheduled by the Office of Court Administration, for a defendant previously sentenced by the Judge; or (3) imposing sentence only via the Polycom RealPresence app or Skype for Business upon a defendant who previously pleaded guilty. When imposing a sentence of imprisonment upon a non-incarcerated defendant, the sentence shall not commence before August 3, 2020.
- 4. To the extent not prohibited by the Governor's March 19, 2020 Order closing all non-life-sustaining businesses, including all law offices except for legal services with respect to an essential judicial service as defined by the President Judge of a Judicial District,

- a. all uncontested motions and agreed-upon, stipulated orders may be submitted by email to the Office of Court Administration (jgreene@nccpa.org) and will be signed by the President Judge and filed by the Office of Court Administration; and
- b. a party or attorney who must present a contested motion or petition to the Court prior to May 6, 2020, which is not specifically set forth in Section II above as an essential judicial service, shall:
  - (1) email a .pdf copy of the motion together with a memorandum of law in accordance with Northampton County Local Rule N210 to the Office of Court Administration (jgreene@nccpa. org);
  - (2) serve the motion and memorandum of law upon the opposing party and attorney of record by email, by first class mail, and by certified mail, return receipt requested, restricted delivery, with a statement to the opposing party and attorney that the opposing party and attorney must, within five days of receipt, email a .pdf copy of the motion together with a memorandum of law in accordance with Northampton County Local Rule N210 to the Office of Court Administration (jgreene@nccpa. org); and
  - (3) if the motion or petition requires testimony, the parties shall arrange for depositions and submit a .pdf copy of the depositions to the Office of Court Administration (jgreene@nccpa.org).

#### 5. Miscellaneous Court

Beginning on May 6, 2020, to the extent not prohibited by the Governor's March 19, 2020 Order closing all non-life-sustaining businesses, including all law offices except for legal services with respect to an essential judicial service as defined by the President Judge of a Judicial District, attorneys and parties may schedule miscellaneous hearings following the procedures set forth below for May 6, 2020, May 13, 2020, May 20, 2020, and May 27, 2020.

- a. The Court will hear all matters allowed by Northampton County Local Rule N209, except all criminal cases. Except as set forth in Section III (3) above, all criminal matters will be handled by the President Judge in the Essential Services Court through May 31, 2020.
- b. A party or attorney shall email a .pdf copy of a praecipe for a miscellaneous hearing, together with the respective motion or petition, and all proposed exhibits to the Office of Court Administration (jgreene@nccpa.org) and to the opposing counselor party at least 7 days prior to the miscellaneous hearing date.
- c. The President Judge will schedule the hearing and assign it to a Judge of the Court of Common Pleas.
- d. The hearings will be scheduled at 30-minute intervals from 9:00 a.m. until 4:00 p.m.
- e. The hearings may **only** be conducted via the Polycom RealPresence app or Skype for Business procedures set forth in Section II above.
- f. Parties and attorneys shall be available 30 minutes before and 30 minutes after the scheduled hearing.
- g. All courtrooms, judicial chambers and judicial residences are equipped with Polycom RealPresence and Skype for Business. Because the Northampton County Courts remain closed to the public, no parties, witnesses or attorneys may appear in person for the hearings.

## 6. Formal Arraignments

- a. Formal arraignments for incarcerated defendants will take place on May 11, 2020, May 12, 2020, May 13, 2020, May 14, 2020 and May 15, 2020 at 9:00 a.m. and 1:00 p.m. **only** via the Polycom RealPresence app or Skype for Business procedures set forth in Section II above.
- b. Attorneys shall participate in the formal arraignment proceedings for incarcerated defendants via the Polycom RealPresence app or Skype for Business.

c. For formal arraignments scheduled from May 11, 2020 through September 3, 2020, pursuant to Rule of Criminal Procedure 571(D), if a defendant wishes to waive appearance at a formal arraignment and is represented by counsel of record who concurs in the waiver, the defendant may waive the formal arraignment by completing the waiver of formal arraignment form attached as Exhibit D. The Court will mail a copy of the waiver of formal arraignment form to the defendant and counsel of record, together with an acknowledgement of formal arraignment and application for ARD or ASP. A defendant who wishes to waive formal arraignment and not appear in person on the scheduled arraignment date, must sign both (1) the acknowledgement of formal arraignment; and (2) the waiver of formal arraignment and return both forms in the stamped, self-addressed envelope at least 14 days before the scheduled arraignment date. A defendant who waives formal arraignment and wishes to apply for ARD or ASP, must complete the ARD or ASP application and return it the District Attorney's office at least 14 days before the scheduled arraignment date.

## 7. Argument Court

- a. Argument Court for March 17, 2020, April 21, 2020, and May 26, 2020 is **CANCELED.**
- b. Except as set forth in Section III (7)(c) below, all cases listed on the March 17, 2020, April 21, 2020, and May 26, 2020 Argument Court lists will be decided based upon the submitted legal briefs.
- c. Attorneys or parties who wish to present oral argument to the Court shall contact the assigned judge's chambers and schedule oral argument. Oral argument may **only** be conducted via two-way simultaneous audio-visual communication with the assigned judge using the Polycom RealPresence app or Skype for Business procedures set forth in Section II above.

- d. The petitions, motions and zoning and land use appeals set forth on the March 17, 2020, April 21, 2020, and May 26, 2020 Argument Court lists are assigned to the judges as set forth in Exhibits A, B, and C for the sole purpose of disposing of such petitions, motions and zoning and land use appeals in conformity with the provisions of this Order.
- e. All applications for continuance of any of the cases set forth on Exhibits A, B, and C shall be emailed to the Office of Court Administration (jgreene@nccpa. org) for decision by the President Judge.

#### 8. Juvenile Court

- a. All juvenile dependency and delinquency proceedings shall take place **only** via the Polycom RealPresence app or Skype for Business procedures set forth in Section II above.
- b. The Office of Court Administration will schedule the hearings before the juvenile division judges and masters.
- c. Parties and attorneys shall be available 30 minutes before and 30 minutes after the scheduled hearing.
- d. All courtrooms, judicial chambers and judicial residences are equipped with Polycom RealPresence. Because the Northampton County Courts remain closed to the public, no parties, witnesses or attorneys may appear in person for the hearings.

#### 9. Domestic Relations De Novo Court

- a. De novo hearings will be conducted on May 18, 2020 and May 19, 2020.
- b. The hearings will be scheduled between 9:00 a.m. and 4:00 p.m.
- c. The hearings may **only** be conducted by the Polycom RealPresence app or Skype for Business procedures set forth in Section II above.
- d. Parties and attorneys shall be available 30 minutes before and 30 minutes after the scheduled hearing.
- e. All courtrooms, judicial chambers and judicial residences are equipped with Polycom RealPresence.

- Because the Northampton County Courts remain closed to the public, no parties, witnesses or attorneys may appear in person for the hearings.
- 10. Settlement conferences before a settlement master shall be conducted only by telephone or by the Polycom RealPresence app or by Skype for Business.
- 11. Conferences before a divorce master shall be conducted only by telephone or by the Polycom RealPresence app or by Skype for Business.
- 12. Child custody conferences before a custody master shall be conducted only by telephone or by the Polycom RealPresence app or Skype for Business. The Custody Division will initiate the call to the parties or, in the case of represented parties, to their attorneys, at the time of the conference. All parties and attorneys shall notify the Custody Division in advance if there is any change to their telephone numbers.
- 13. Hearings pursuant to the Mental Health Procedures Act, 50 P.S. § 7101, shall be conducted only by telephone.
- 14. Domestic Relations support conferences shall be conducted only by telephone or by the Polycom RealPresence app or by Skype for Business. The Domestic Relations Division will initiate the call to the parties or, in the case of represented parties, to their attorneys, at the time of the conference. All parties and attorneys shall notify the Domestic Relations Division in advance if there is any change to their telephone numbers.
- 15. Except as set forth below, the Northampton County Magisterial District Courts shall remain **CLOSED TO THE PUBLIC** through May 31, 2020 at 4:30 p.m.
- 16. During "normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, each Magisterial District Court shall only allow entry to the Magisterial District Court facilities to: (1) members of the press; (2) attorneys, police officers, and witnesses for a preliminary hearing of an incarcerated defendant (all preliminary hearings for all defendants

who are not in prison are continued to a date after May 31, 2020); and (3) law enforcement officers for the filing and subsequent processing of criminal, summary criminal, and non-traffic cases. Preliminary hearings of incarcerated defendants before Magisterial District Judges shall be conducted via two-way simultaneous audio-visual communication with the Magisterial District Court by using Polycom video conferencing or Skype Business.

17. Attorneys and parties who wish to participate by using Polycom RealPresence shall contact the Magisterial District Judge to receive approval for participation via Polycom RealPresence and to obtain the IP address sign-in information for the scheduled hearing. Members of the press may view the proceedings in the Magisterial District Court or by using the Polycom RealPresence app or Skype for Business.

The Magisterial District Judge technicians will email the meeting invitation to the hearing participants. At the scheduled time of the hearing, the participants will click on the "Join a Skype Meeting" link in their email client which will open a small web application connecting the participant to the meeting without the need to download an app on their device.

- 18. Payments of fines and costs for summary criminal, traffic, and non-traffic cases pending before a Magisterial District Judge shall only be made online at [https://ujsportal.pacourts.us/PayOnline.aspx].
- 19. Landlords may mail requests to the Magisterial District Judge for orders of possession and orders for eviction with a check for the required filing fee. Pursuant to the Pennsylvania Supreme Court's order dated April 1, 2020, no order of eviction shall be executed until after April 30, 2020. Private criminal complaints and civil complaints and civil complaints may be mailed to the Magisterial District Judge with a check for the required filing fee.
- 20. All preliminary arraignments by Magisterial District Judges, regardless of whether the arrest is made during "normal business hours" or "at times other than normal business hours" as those terms are defined in Northampton County Administrative Order 2007-3, shall be conducted pursuant to paragraph 4(A) of Northampton County Administrative Order 2007-3.
- 21. All applications for arrest and search warrants to Magisterial District Judges, and the issuance thereof by Magisterial District Judges, regardless of whether the application is made during "normal business hours" or "at times other than normal business hours" as those terms are defined in Northampton County Administrative Order 2007-3, shall be conducted pursuant to paragraph 8 of Northampton County Administrative Order 2007-3.
- 22. All emergency petitions and hearings for protection from abuse, protection from elder abuse, and protection of victims of sexual violence or intimidation which are presented between the hours of 2:30 p.m. and 4:30 p.m., Monday through Friday, and "at times other than normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, shall be conducted by Magisterial District Judges pursuant to paragraph 9 of Northampton County

Administrative Order 2007-3. Complaints for indirect criminal contempt of protection from abuse, protection from elder abuse, and protection of victims of sexual violence or intimidation orders which are presented between the hours of 2:30 p.m. and 4:30 p.m., Monday through Friday, and "at times other than normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, shall be processed by Magisterial District Judges pursuant to paragraph 9 of Northampton County Administrative Order 2007-3.

- 23. During "normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, each Magisterial District Judge shall conduct the proceedings set forth in Section III (20)-(21) of this Order which occur in his/her Magisterial District.
- 24. "At times other than normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, the Magisterial District Judge who is temporarily assigned as the issuing authority for all Magisterial Districts in the Third Judicial District pursuant to the December 16, 2019 Order of Court shall conduct both (1) the proceedings set forth in Section III (20)-(21) of this Order; and (2) all proceedings set forth in Section III (22) of this Order.

#### IV.

#### It is further **ORDERED** as follows:

1. In order to limit the risk of exposure to Coronavirus (COVID-19) to the public, and pursuant to this Court's Declaration of a judicial emergency in the Third Judicial District and the mandate of Pennsylvania Rule of Judicial Administration 1952(B)(2) to "take necessary action to provide for the ... safety of court personnel, court users and the public ...," the Court has revised the 2020 Court Calendar to increase the number of sessions for Formal Arraignments, Summary Criminal Appeals, and ARD/ASP hearings in order to limit the number of people present in courtrooms. The

- Revised 2020 Court Calendar is attached hereto as Exhibit E [see cream insert published herein].
- 2. The requirements in Northampton County Administrative Order 2020-5, directing that Magisterial District Judges provide requested case records to the public or press, shall apply to all proceedings in Section III (20)-(21) of this Order, regardless of whether the proceeding occurs during "normal business hours" or "at times other than normal business hours" as those terms are defined in Northampton County Administrative Order 2007-3. Members of the press may view the proceedings in Section III (20) of this Order by using the Polycom RealPresence app for Androids or Apple devices.
- 3. Nothing in this Order amends or changes the terms of paragraph 4(A) of Northampton County Administrative Order 2015-9.
- In accordance with the Order issued on April 15, 2020 4. by the secretary of the Pennsylvania Department of Health. and the mandate of Pennsylvania Rule of Judicial Administration 1952(B)(2) to "take necessary action to provide for the ... safety of court personnel, court users and the public ...," all court employees who are under the supervision and authority of the President Judge, and all individuals who enter any courtroom or court facility under the supervision and authority of the President Judge, including all Magisterial District Courts, the Office of Court Administration, the Domestic Relations Building, the Juvenile Justice Center, and the offices of Adult Probation and Pretrial Services, shall wear a mask which covers the mouth and nose and shall maintain a distance of at least six feet from any other individual while in the courtroom or court facility. The masks

shall be made and worn in accordance with CDC guidelines found at https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/diy-cloth-face-coverings.html and attached as Exhibit F. Notwith-standing the foregoing, masks shall not be required for individuals who cannot wear a mask due to a medical condition (including children under the age of two) or for employees who are using break time to eat or drink.

- 5. The following individuals will be prohibited from entering any courtroom or court facility under the supervision and authority of the President Judge, including all Magisterial District Courts, the Office of Court Administration, the Domestic Relations Building, the Juvenile Justice Center, and the offices of Adult Probation and Pretrial Services:
  - Have been directed to quarantine, isolate or selfmonitor at home for the coronavirus by any doctor, hospital or health agency; or
  - Have been diagnosed with, or have had close contact with anyone diagnosed with, COVID-19; or
  - Have flulike symptoms; or
  - Are not wearing a mask in accordance with Section IV (4) above.

This Order shall become effective on April 20, 2020 at 8:30 a.m. and shall expire on May 31, 2020 at 4:30 p.m. unless extended by further Order of Court. The requirements set forth in Section IV (4) and (5) of this Order shall remain in effect until further Order of Court.

## Use of Cloth Face Coverings to Help Slow the Spread of COVID-19

#### **How to Wear Cloth Face Coverings**

Cloth face coverings should-

- · fit snugly but comfortably against the side of the face
- · be secured with ties or ear loops
- · include multiple layers of fabric
- · allow for breathing without restriction
- be able to be laundered and machine dried without damage or change to shape

#### CDC on Homemade Cloth Face Coverings

CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies), **especially** in areas of significant community-based transmission.

CDC also advises the use of simple cloth face coverings to slow the spread of the virus and help people who may have the virus and do not know it from transmitting it to others. Cloth face coverings fashioned from household items or made at home from common materials at low cost can be used as an additional, voluntary public health measure.

Cloth face coverings should not be placed on young children under age 2, anyone who has trouble breathing, or is unconscious, incapacitated or otherwise unable to remove the cloth face covering without assistance.

The cloth face coverings recommended are not surgical masks or N-95 respirators. Those are critical supplies that must continue to be reserved for healthcare workers and other medical first responders, as recommended by current CDC quidance.

#### Should cloth face coverings be washed or otherwise cleaned regularly? How regularly?

Yes. They should be routinely washed depending on the frequency of use.

How does one safely sterilize/clean a cloth face covering?

A washing machine should suffice in properly washing a cloth face covering.

#### How does one safely remove a used cloth face covering?

Individuals should be careful not to touch their eyes, nose, and mouth when removing their cloth face covering and wash hands immediately after removing.


#### Materials

- Two 10"x6" rectangles of cotton fabric
- Two 6" pieces of elastic (or rubber bands, string, cloth strips, or hair ties)
- Needle and thread (or bobby pin)
- Scissors
- · Sewing machine




#### Tutorial

 Cut out two 10-by-6-inch rectangles of cotton fabric. Use tightly woven cotton, such as quilting fabric or cotton sheets. T-shirf fabric will work in a pinch. Stack the two rectangles; you will sew the cloth face covering as if it was a single piece of fabric.




Fold over the long sides ¼ inch and hem. Then fold the double layer of fabric over ½ inch along the short sides and stitch down.




 Run a 6-inch length of 1/8-inch wide elastic through the wider hem on each side of the cloth face covering. These will be the ear loops. Use a large needle or a bobby pin to thread it through. Tie the ends tight.


Don't have elastic? Use hair ties or elastic head bands. If you only have string, you can make the ties longer and tie the cloth face covering behind your head.



4. Gently pull on the elastic so that the knots are tucked inside the hem. Gather the sides of the cloth face covering on the elastic and adjust so the mask fits your face. Then securely stitch the elastic in place to keep it from slipping.




