- 14. Divorce Master conferences and hearings;
- 15. Asbestos pretrial conferences (April 1, 2020);
- 16. Mortgage foreclosure conferences;
- 17. License Suspension Appeals (March 19, 2020, March 26, 2020, April 2, 2020 and April 9, 2020);
- 18. Preliminary hearings before Magisterial District Judges of non-incarcerated defendants; and

 - 3. Bench warrant (criminal and domestic relations) hearings;
 - 4. Bail modification and revocation hearings;
 - 5. Guilty plea hearings;

- 6. Sentencing hearings;
- 7. Gagnon I hearings;
- 8. Gagnon II parole, probation and intermediate punishment revocation hearings; and
- 9. Petition for Parole hearings.
- VIII. All hearings and proceedings held pursuant to the Rules of Juvenile Court Procedure shall **only** be conducted by use of two-way simultaneous audiovisual communication.
 - IX. The duration of an order appointing an Emergency Guardian of the person or estate of an incapacitated person pursuant to 20 Pa.C.S.A. § 5513 shall be extended from 72 hours to 30 days from date of issuance of the order.
 - X. The duration of an order granting a temporary *ex parte* Protection from Abuse petition and scheduling a final hearing pursuant to 23 Pa.C.S.A. § 6107(b) shall be extended such that the date of the hearing pursuant to 23 Pa.C.S.A. § 6107(a) shall be extended from 10 business days to 30 business days from the date of the issuance of the temporary order. All final hearings previously scheduled pursuant to 23 Pa.C.S.A. § 6107(a) for a date between March 17, 2020 and April 14, 2020 shall be continued until April 15, 2020 at 1:00 p.m. and the temporary orders in those cases shall be extended until that time.
 - XI. Complaints for child custody and petitions for modification or contempt of child custody shall be filed by mail to the Office of Court Administration, along with all required filing fees, related documents and a self-addressed, stamped envelope.
 - XII. Civil Pretrial conferences scheduled for March 24, 2020 shall be conducted only by telephone. The Court will initiate the call to the parties or, in the case of represented parties, to their attorneys, at the time of the conference.

- XIII. Child Custody conferences before a Custody Master shall be conducted only by telephone. The custody office will initiate the call to the parties or, in the case of represented parties, to their attorneys, at the time of the conference. To the extent feasible, attorneys should arrange to have their clients present in their offices with them at the time of the conference. If an attorney cannot arrange to have the client present in the attorney's office, the attorney shall arrange to be able to speak to the client by telephone during the conference. All parties and attorneys shall notify the Court in advance if there is any change to their telephone numbers.
- XIV. Hearings pursuant to the Mental Health Procedures Act, 50 P.S. § 7101, shall be conducted only by telephone.
- XV. Domestic Relations support conferences shall be conducted only by telephone. The Domestic Relations Division will initiate the call to the parties or, in the case of represented parties, to their attorneys, at the time of the conference. To the extent feasible, attorneys should arrange to have their clients present in their offices with them at the time of the conference. If an attorney cannot arrange to have the client present in the attorney's office, the attorney shall arrange to be able to speak to the client by telephone during the conference. All parties and attorneys shall notify the Domestic Relations Division in advance if there is any change to their telephone numbers.
- XVI. Payments of fines and costs for cases pending before a Magisterial District Judge shall only be made online at https://ujsportal.pacourts.us/PayOnline.aspx. No payments will be accepted at the Magisterial District Courts.

- XVII. Uncontested motions and agreed-upon, stipulated orders shall be submitted by mail to the Office of Court Administration (jgreene@nccpa.org) and will be signed by the President Judge.
- XVIII. Because Motions Court and Miscellaneous Court are suspended through April 14, 2020 due to the general, statewide judicial emergency and this Court's Declaration of a judicial emergency in the Third Judicial District, a party or attorney who must present a contested motion or petition to the Court prior to April 14, 2020 which is not specifically set forth in Section XIX below as an essential judicial service, shall:
 - Email a .pdf copy of the motion to the office of Court Administration (jgreene@nccpa. org), together with a memorandum of law in accordance with Northampton County Local Rule N210; and
 - 2. Serve the motion and memorandum of law upon the opposing party and attorney of record by email, by first class mail, and by certified mail, return receipt requested, restricted delivery, with a statement to the opposing party and attorney that the opposing party and attorney must, within five days of receipt, email a .pdf copy of the motion to the office of Court Administration (jgreene@nccpa.org), together with a memorandum of law in accordance with Northampton County Local Rule N210.

If the motion or petition requires testimony, the parties shall arrange for depositions and submit a .pdf copy of the depositions to the Office of Court Administration (j.greene@nccpa.org). The Court will thereafter decide the motion and issue an order.

- XIX. Pursuant to the Pennsylvania Supreme Court's Order dated March 16, 2020, requiring Judicial Districts under a judicial emergency to continue to provide essential judicial services:
 - 1. Magisterial District Judges will remain continuously available 24 hours per day (subject to the limitations set forth in Northampton County Administrative Order 2015-9) to handle:
 - a. preliminary arraignments;
 - complaints for indirect criminal contempt of a protection from abuse order;
 - c. emergency petitions for protection from abuse;
 - d. emergency petitions for protection from elder abuse;

- h. petitions for Emergency Guardian of the person or estate of an incapacitated person pursuant to 20 Pa.C.S.A. § 5513;
- actions for emergency child protective services by the Northampton County Division of Children, Youth and Families;
- j. preliminary injunction proceedings where the moving party can establish a threat of irreparable harm, in which case, before appearing in Court, the moving party shall email a .pdf copy of the motion to the office of Court Administration (j.greene@nccpa.org), together with a memorandum of law in accordance with Northampton County Local Rule N210, and thereafter, the Court Administrator will contact the parties and inform them whether the President Judge has approved an emergency hearing in the matter; and
- k. petitions for emergency child custody pursuant to Pa.R.C.P. 1915.4, where there is an immediate danger to the

safety, health or well-being of the child.

The proceedings listed in paragraph XIX (3) of this order may be conducted by use of two-way simultaneous audio-visual communication, including but not limited to Polycom video conferencing, Skype and Facetime.

- Have flu-like symptoms.

AND NOW, this 19th day of March, 2020, pursuant to the Pennsylvania Supreme Court's Order dated March 16, 2020 declaring a general, statewide judicial emergency until April 14, 2020 in order to limit the risk of exposure to Coronavirus (COVID-19) to the public, this Court's Declaration of a judicial emergency in the Third Judicial District, the Pennsylvania Supreme Court's Order dated March 18, 2020 stating that the Courts of Pennsylvania are "CLOSED TO THE PUBLIC," and pursuant to Pennsylvania Rule of Judicial Administration 1952, it is hereby ORDERED that:

- 1. Courtroom 1 of the Northampton County Courthouse will remain open during Court business hours as an "Essential Services Court." The President Judge of the Northampton County Court of the Common Pleas is assigned to **solely** preside over the Essential Services Court to handle all the proceedings set forth in:
 - a. Paragraphs VII(5)-(7), (9), XIX(2), and (3)(a)-(k) of Northampton County Administrative Order 2020-9;
 - Motions for bail modification for incarcerated defendants awaiting hearings for Gagnon II parole, probation, and intermediate punishment revocation hearings;
 - c. Juvenile emergency shelter and detention hearings; and

- d. Any pleading or motion relating to public health concerns and involving immediate and irreparable harm.
- During the effective period of this Order, hearings pursuant to the Mental Health Procedures Act, 50 P.S. § 7101, shall be conducted **only** by telephone by a Court Master;
- 3. In order to limit the risk of exposure to Coronavirus (COVID-19) to the public, and pursuant to this Court's Declaration of a judicial emergency in the Third Judicial District and the mandate of Pennsylvania Rule of Judicial Administration 1952(B)(2) to "take necessary action to provide for the ... the safety of court personnel, court users and the public ...," it is hereby **ORDERED** that:
 - a. During the effective period of this Order, all court cases previously assigned to any other Judge of the Court of Common Pleas, or any of the administrative judges of any of the divisions of the Court of Common Pleas, shall be reassigned to the President Judge;
 - b. Unless specifically assigned by written Order of Court issued and filed by the President Judge, all other Judges of the Court of Common Pleas, and all administrative judges of any of the divisions of the Court of Common Pleas, shall not conduct any of the proceedings set forth in paragraph 1(a)-(d) above, and shall not conduct any other type of proceeding or hearing other than conducting by telephone the preassigned civil pretrial conferences scheduled for March 25, 2020. See Paragraph XII of Northampton County Administrative Order 2020-9; and
 - c. The Sheriff of Northampton County shall only allow entry to court facilities, which are under the direction and control of the President Judge, to attorneys, parties and

witnesses for the proceedings set forth above in paragraph 1(a)-(d).

- 4. All preliminary arraignments by magisterial district judges, regardless of whether the arrest is made during "normal business hours" or "at times other than normal business hours" as those terms are defined in Northampton County Administrative Order 2007-3, shall be conducted pursuant to paragraph 4(A) of Northampton County Administrative Order 2007-3;
- 5. During "normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, each magisterial district court shall remain open to the Commonwealth for the filing and subsequent processing of criminal case filings;
- 6. All applications for arrest and search warrants to magisterial district judges, and the issuance thereof by magisterial district judges, regardless of whether the application is made during "normal business hours" or "at times other than normal business hours" as those terms are defined in Northampton County Administrative Order 2007-3, shall be conducted pursuant to paragraph 8 of Northampton County Administrative Order 2007-3;
- 7. All emergency petitions and hearings for protection from abuse, protection from elder abuse, and protection of victims of sexual violence or intimidation, which are presented between the hours of 2:30 p.m. to 4:30 p.m., Monday through Friday, and "at times other than normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, shall be conducted by magisterial district judges pursuant to paragraph 9 of Northampton County Administrative Order 2007-3. Complaints for indirect criminal contempt of protection from abuse, protection from elder abuse, and protection of

victims of sexual violence or intimidation orders, which are presented between the hours of 2:30 p.m. to 4:30 p.m., Monday through Friday, and "at times other than normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, shall be processed by magisterial district judges pursuant to paragraph 9 of Northampton County Administrative Order 2007-3;

- 8. During "normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, each magisterial district judge shall conduct the proceedings set forth in paragraphs 4 through 6 of this Order, which occur in his/her magisterial district; and
- 9. "At times other than normal business hours" as that term is defined in Northampton County Administrative Order 2007-3, the magisterial district judge who is temporarily assigned as the issuing authority for all magisterial districts in the Third Judicial District pursuant to the December 16, 2019 Order of Court, shall conduct the proceedings set forth in paragraphs 4 through 6 of this Order, and all proceedings set forth in paragraph 7 of this Order.

It is further **ORDERED** that:

- 1. The requirements in Northampton County Administrative Order 2020-5, directing that magisterial district judges provide requested case records to the public or press, shall apply to all proceedings in paragraphs 4 through 6, regardless of whether the proceeding occurs during "normal business hours" or "at times other than normal business hours" as those terms are defined in Northampton County Administrative Order 2007-3:
- 2. Nothing in this Order amends or changes the terms of:

- a. Paragraph 4(A) of Northampton County Administrative Order 2015-9; or
- b. The terms of paragraph VII(2) Northampton County Administrative Order 2020-9. Therefore, magisterial district judges will continue to conduct preliminary hearings as set forth in paragraph VII(2) Northampton County Administrative Order 2020-9;
- 3. To the extent this Order conflicts with Administrative Order 2020-9, this Order shall govern; and
- 4. The Court will direct the production of posters for the entry doors of any courtroom or court facility under the direction of the President Judge, the Office of Court Administration, the Domestic Relations Building, the Juvenile Justice Center, the offices of Adult Probation and Pretrial Services, and the entry door of all Magisterial District Courts, which will notify the public of the mandates of the Pennsylvania Supreme Court's March 18, 2020 Order and Northampton County Administrative Orders 2020-9 and 2020-10. This Order shall become effective on March 19, 2020 at 4:30 p.m. and expire on April 3, 2020 at 4:30 p.m. unless extended by further Order of Court.

- A. The public counters for all three Superior Court Offices of the Prothonotary are CLOSED until further Order of this Court. The Court will continue to accept filings ONLY through PACFile electronic filing, through the United States Postal Service, or by commercial delivery carrier.
- B. The due dates for all filings due in the Superior Court between March 17, 2020, and April 17, 2020, are EXTENDED by 30 days. Filings for matters classified as Children's Fast Track, **see** Pa.R.A.P. 102 (relating to definitions), are NOT SUBJECT to this extension;
- C. All timelines imposed by Pennsylvania Rule of Appellate Procedure 903, for appeals from orders entered between March 17, 2020, and April 17, 2020, that would be subject to the Superior Court's jurisdiction, are EXTENDED by 30 days. The courts of common pleas are directed to ensure all notices of appeals filed in their courts bear a date stamp of the court's receipt of the notice of appeal, and that each notice of appeal either bears an electronic-filing stamp or is attached to the postmark from the envelope that contained the notice of appeal. Notices of appeal in matters classified as Children's Fast Track, see Pa.R.A.P. 102 (relating to definitions), are NOT SUBJECT to this extension;

- D. The due dates for applications for reconsideration or reargument, as imposed by Pennsylvania Rule of Appellate Procedure 2542(a), are EXTENDED by 30 days. The due dates for applications for reconsideration or reargument of Children's Fast Track cases, as imposed by Pennsylvania Rule of Appellate Procedure 2542(b), are NOT SUBJECT to this extension;
- E. Any requests for extensions of time or other extraordinary relief related to applications filed pursuant to the Wiretapping and Electronic Surveillance Control Act, 18 Pa.C.S. §§ 5701, et seq. ("Wiretap Act") shall be made to the judge who has been assigned to the particular wiretap application or, if the wiretap application has not yet been assigned, then to the Wiretap Act Supervising Judge. The time limits for any order authorizing the interception of any wire, electronic or oral communication as set forth in § 5712(b) of the Wiretap Act shall remain in full force and effect; AND
- F. All emergency motions shall be filed through the PACFile electronic filing system, and must be clearly titled as an Emergency Motion. To the extent a party is unable to file an emergency motion on PACFile, they are encouraged to call the respective district's Prothonotary's Office, which phone numbers may be found at: http://www.pacourts.us/courts/superior-court/prothonotarys-addresses. Parties are on notice that emergency motions may take longer than usual to address.

Children's Fast Track filings must be made within the time established by general rule using the PACFile electronic filing system, *see* Pa.R.A.P. 125 (relating to electronic filing), or by proper postmark or receipt as provided by the United States Postal Service or commercial delivery carrier.

Any future Orders regarding Superior Court operations during the COVID-19 situation shall be docketed at this Administration Docket number and posted on the Unified Judicial System website. This Court's Prothonotary is DIRECTED to transmit this Order to the Pennsylvania Bar Association, with a request that such association promptly forward the notice to all members and all local bar associations.

This Order shall terminate on April 17, 2020, unless renewed on or before that date.
