TEMPORARY CONTINUANCE : STANDING OF CIVIL AND CRIMINAL JURY : ORDER

TRIALS DUE TO THE EXIGENT : CIRCUMSTANCES CREATED : BY COVID-19

The Governor of the Commonwealth of Pennsylvania has declared the existence of a disaster emergency throughout the Commonwealth to address the threat posed by the corona virus disease 2019 (COVID-19). An increased number of confirmed cases of COVID-19 have been reported in this district in recent days. The Centers for Disease Control and Prevention and State and local public health authorities have advised that precautions be taken to avoid exposure to the virus and prevent its spread, including implementing social distancing measures such as avoiding large gatherings and refraining from non-essential travel. These and other recent developments with regard to COVID-19 in the geographic area comprising this district adversely affect the Court's ability to obtain an adequate complement of trial jurors from a fair cross-section of the community. In light of these developments, and to protect public health, reduce the size of public gatherings, and reduce unnecessary travel within this district, while allowing the Court to continue to continue to perform its constitutional duties, the Court issues the following Standing Order, effective immediately:

- 1. The United States District Court for the Eastern District of Pennsylvania will remain open for business in all Court locations (Philadelphia, Allentown, Reading, and Easton), subject to the following limitations.
- 2. All civil and criminal jury trials and grand jury selections scheduled to begin between now and April 13, 2020, before any district or magistrate judge in any courthouse in the Eastern District of Pennsylvania are CONTINUED pending further Court order.

- 3. Aside from ordering a jury trial, individual judges presiding over criminal proceedings may take such actions consistent with this Order as may be lawful and appropriate to ensure the fairness of the proceedings and preserve the rights of the parties.
- 4. The Court is cognizant of the right of criminal defendants to a speedy and public trial under the Sixth Amendment and the particular application of that right in cases involving defendants who are detained pending trial. In light of the developments regarding COVID-19 in this district outlined above and their impact on the Court's ability to obtain an adequate complement of trial jurors, the Court finds the ends of justice served by granting a continuance outweigh the best interest of the public and each defendant in a speedy trial. The time period of any continuance entered as a result of this Standing Order shall therefore be excluded under the Speedy Trial Act, 18 U.S.C. § 3161(h)(7)(A). Any motion by a criminal defendant seeking an exception to this Standing Order for the purpose of exercising the defendant's speedy trial rights shall be referred to the Chief Judge.
  - 5. Grand juries shall continue to meet.
- 6. All Central Violations Bureau proceedings between now and April 13, 2020, are CONTINUED pending further Court order.
- 7. All mass public gatherings, other than court proceedings, are SUSPENDED at all Court locations within the Eastern District of Pennsylvania. This includes, but is not limited to, group tours and visits, moot courts and mock trials, bar group meetings, seminars, and naturalization ceremonies.
- 8. The Eastern District of Pennsylvania will remain open for all other business. The public is encouraged to continue utilizing Court services while following all applicable public health guidelines.
- 9. This Standing Order will expire no later than April 13, 2020, unless extended by further Court order.

## COMMONWEALTH of PENNSYLVANIA v. JOSE ALBERTO RODRIGUEZ, JR., Defendant

Suppression—Suspicion—Expectation of Privacy.

Finding that the police had probable cause to believe that Defendant had just engaged in a drug transaction, the Court found that the stop and search of his person was constitutional, and denied Defendant's motion to suppress the fruits of that search. Defendant's motion to suppress the search of a residence was also denied where the search of his person and the tip of a reliable confidential informant combined to provide probable cause that Defendant was dealing drugs from that home. Furthermore, given that Defendant claimed not to reside in that home, he had no reasonable expectation of privacy therein and thus no standing upon which to seek suppression of the fruits of the search thereof.

#### *ORDER*

AND NOW, this 18th day of June 2019, upon consideration of Defendant's Motion to Suppress Evidence, and following a hearing, it is hereby ORDERED that the motion is DENIED.

#### STATEMENT OF REASONS

Defendant Jose Alberto Rodriguez, Jr. is charged herein with two counts of Possession of a Controlled Substance with Intent to Deliver—35 Pa. C.S. §780-113(a)(30) and two counts of Possession of a Controlled Substance—35 Pa. C.S. §780-113(a)(16), arising out of a stop, arrest and two searches—both of Defendant's person and a home at 1834 Lynfield Drive—that occurred on November 1, 2018 in the City of Bethlehem. In the motion now before the Court, Defendant contends that the stop, arrest and searches of his person and the residence in question were unconstitutional, insofar as they were made without the requisite level of suspicion required in order for law enforcement officers to validly stop, arrest or search an individual, or to search a particular location.

The Commonwealth bears the burden of proof when a defendant files a motion to suppress evidence. That burden is to establish, by a preponderance of the evidence, that the challenged evidence is admissible and that it was not obtained in violation of the defendant's rights. *Commonwealth v. Hernandez*, 892 A.2d 11 (Pa. Super. 2006). If the Commonwealth fails to meets its burden, the evidence obtained in violation of the defendant's rights will be suppressed and thus inadmissible at trial. *See Katz v. United States*,

389 U.S. 347 (1967). At a suppression hearing, the court bears the sole responsibility of determining the credibility of the witnesses and the weight to be given to their testimony. *See Commonwealth v. Elmobdy*, 823 A.2d 180 (Pa. Super. 2003). The court is free to believe all, some or none of the evidence presented at the suppression hearing. *Id*.

Having heard all of the testimony presented at the May 31, 2019 suppression hearing, and having reviewed the transcript of the preliminary hearing before Magisterial District Justice Nicholas Englesson on February 4, 2019, we find that the Commonwealth has established the following facts: In the early evening hours of November 1, 2018, Detective Sergeant Michael Mish (Mish) conducted informal surveillance in the area of Figueroa's Market in Bethlehem, an area known to him, by way of personal observation and citizen complaints, to be an area of drug trafficking. Mish was parked at the corner of 9th Street and Lynn Avenue. By way of background, Mish has been a City of Bethlehem police officer since 1999. He began in the patrol division, and was assigned to the Special Operations Vice Unit in 2002. In December 2015, he was placed in charge of that unit and remains in charge of that unit now. He is also a member of the Northampton County Drug Task Force, and worked as a federal agent for the Drug Enforcement Administration for 13 years. He has extensive training in narcotics investigations, including how drugs are distributed and transported. He has observed several hundreds of drug transactions during his career.

At approximately 7:45 p.m. on November 1, 2018, during his surveillance, Mish observed a blue Chrysler pull up to the curb in front of him at 10th Street and Lynn Avenue, across the street from the market. No one entered or exited the vehicle for several minutes. Mish then ran the registration of the vehicle, bearing Pennsylvania plate number KBY7902, and learned that the vehicle was registered to Oscar York, an individual known to Mish as a narcotics dealer with two prior convictions, who was known to be selling drugs of late in the Bethlehem area. Several minutes after the vehicle had arrived, Mish observed an individual, only later identified as this Defendant, approach the Chrysler on foot and enter the passenger door. The vehicle then drove down Lynn Avenue, and was followed by Detective Casella, a member of Mish's team on the Special Operations Vice Unit. The vehicle was followed as it drove for approximately one minute in a circle from its starting position along Argus Street, coming to rest on 9th Street approximately two blocks from where it had begun, in Mish's line of sight down 9th Street. Mish testified that this type of conduct—an individual entering a vehicle and then riding in the vehicle for a very short distance in a circular route—is very typical of drug transactions, in his experience. The same individual seen entering the vehicle then exited the vehicle and began walking down 9th Street towards Mish, passing in front of him. Mish then exited his vehicle and requested to speak with the individual, at which time the man moved as though to flee. Detective Marques, another member of Mish's team, had just entered the scene at Mish's request and apprehended the individual, having been advised by Mish via ongoing radio transmissions of his observations of the individual. As the man was apprehended, a white pill fell from his person onto the ground. He was then patted down and a bag of cocaine was found on his person, as well as another pill. The quantity of cocaine found on his person had a street value of approximately \$400. After placing the individual under arrest, Mish was able to identify him as this Defendant.

Both the Fourth Amendment to the United States Constitution and Article I, Section 8 of the Constitution of the Commonwealth of Pennsylvania secure the rights of individuals from unreasonable searches and seizures, "thereby ensuring the 'right of each individual to be let alone." Commonwealth v. Barber, 889 A.2d 587, 592 (Pa. Super. 2005). Contacts between police and citizens are generally placed into one of three categories: mere encounters, investigative detentions and arrests, each with a specific level of justification that the law requires in order for the contact to be constitutionally permissible. Mere encounters—situations in which a reasonable person would feel free to leave—require no justification. An investigative detention—a situation that involves a brief stop and questioning during which a reasonable person would not feel free to leave—requires an objectively reasonable suspicion that the person stopped is involved in criminal activity. Finally, an arrest requires probable cause, which is defined as "facts available which would justify a person of reasonable caution in the belief that a crime had been committed and that the individual arrested was the probable perpetrator." Commonwealth v. Wilder, 461 Pa. 597, 600, 337 A.2d 564, 566 (1975).

At the time that Detective Mish exited his vehicle and asked to speak with the Defendant, he was attempting to engage Defendant in an investigative detention, requiring reasonable suspicion in order to justify his conduct. Reasonable suspicion is present when an "officer is able to articulate specific observations which, in conjunction with reasonable inferences derived from those observations, led him reasonably to conclude, in light of his experience, that criminal activity was afoot and that the person he stopped was involved in that activity." *Commonwealth v. Chambers*, 55 A.3d 1208, 1215 (Pa. Super. 2012). In light of Mish's years of experience and countless similar observations of drug transactions, we believe that it was reasonable for him to believe that this Defendant had just engaged in a drug transaction, and that his stop of the Defendant was therefore privileged.

In order for an individual to be placed under arrest, however, probable cause is required. Again, probable cause is such information that is "sufficient to warrant a person of reasonable caution in the belief that an offense [had] been or [was] being committed." *Commonwealth v. Runyan*,

160 A.3d 831, 837 (Pa. Super. 2017). "In determining whether probable cause ... exists, we must not focus on isolated factors, but must, rather, look at the totality of the circumstances surrounding the arrest." *Commonwealth v. Kinnon*, 308 Pa. Super. 28, 30, 453 A.2d 1051, 1052 (1982). Given all of the activity observed by Mish in light of his extensive experience as a narcotics officer, and the Defendant's reaction when asked by Mish to stop for questioning, we believe that the totality of the circumstances were such that a person of reasonable caution would believe that Defendant had just been engaged in a narcotics offense, and thus the arrest by Marques and Mish was likewise privileged. That being the case, suppression of the evidence obtained as a result of that attempted stop and eventual arrest is not warranted, and Defendant's motion must be denied on this point.

Following Defendant's arrest and identification, Detective Patrick Maczko (Maczko) of the Bethlehem Police Department made an application for a search warrant of the residence at 1834 Lynfield Drive, Bethlehem. Defendant contends that the warrant for that residence was issued without probable cause. In considering Defendant's challenge to the issuance of the warrant, we must examine the affidavit submitted in support thereof. Our review is "confined to the averments contained within the four corners of the affidavit," and we must view it "in a common-sense, non-technical manner." Commonwealth v. Wallace, 615 Pa. 395, 409, 42 A.3d 1040, 1048 (2012); Commonwealth v. Torres, 564 Pa. 86, 97, 764 A.2d 532, 538 (2001).

In the affidavit of probable cause in support of the warrant application, Maczko set forth his extensive experience as a narcotics officer, noting inter alia, that he has been employed by the Bethlehem Police Department since 2004, first as a patrol officer, then as a member of the Street Crimes Unit and, since March 2013, as a member of the Special Operations Vice Unit, tasked with narcotics investigations. Maczko is a member of the Northampton County Drug Task Force and the Lehigh County Drug Task Force and has participated in hundreds of narcotics investigations, including the execution of search warrants of residences. In his capacity as a narcotics officer, Maczko received information from a known, reliable confidential informant that this Defendant was selling drugs from 1834 Lynfield Drive, Bethlehem. This informant was deemed reliable in light of information he had provided in the past leading to three arrests and the seizure of numerous controlled substances and contraband. Having also conducted surveillance of this Defendant after receiving the tip, Maczko observed this Defendant, on multiple occasions, arrive at and depart from that address. Maczko also noted in his affidavit of probable cause that this Defendant had prior convictions for narcotics offenses. In addition, the affidavit relates the events of the evening of November 1, 2018, including that Defendant was observed entering the passenger seat of a blue Chrysler after arriving at the vehicle on foot, riding in the vehicle for approximately one minute, and then exiting the vehicle, later to be detained and found to have an oxycodone pill and \$500 of cocaine on his person, a distributable quantity.

Again, when the issuance of a warrant is challenged, "judicial review is confined to the averments contained within the four corners of the affidavit of probable cause." Commonwealth v. Wallace, supra at 408, 42 A.3d at 1048. "Our duty in conducting this review is to determine whether the issuing magistrate had a substantial basis for concluding that probable cause existed." Id. at 410, 42 A.3d at 1049, citing Commonwealth v. Torres, 564 Pa. 86, 101, 764 A.2d 532, 540 (2001). We must be mindful, of course, that probable cause is a fluid concept and "as the very name implies, we deal with probabilities. These are not technical; they are the factual and practical considerations of everyday life on which reasonable and prudent men, not legal technicians, act." Brinegar v. United States, 338 U.S. 160, 175 (1949). It is "only the probability, and not a prima facie showing, of criminal activity [that] is the standard of probable cause." Spinelli v. United States, 393 U.S. 410, 419 (1969). Furthermore, we are mindful that a magistrate's "determination of probable cause should be paid great deference by reviewing courts." Id. Applying this standard to the affidavit of probable cause offered in support of the search warrant authorized for the residence at 1834 Lynwood Drive, Bethlehem on November 1, 2018, we find that the warrant was properly issued upon probable cause. Accordingly, Defendant's Motion to Suppress Evidence must be denied on this point as well.

As a final matter, we must note that while we have found that the search warrant was properly issued upon probable cause, insofar as Defendant contends that he did not reside at 1834 Lynfield Drive, Bethlehem, but rather resided with his mother at 235 Union Boulevard, Bethlehem, Defendant has failed to articulate how he has standing to challenge the search warrant, by demonstrating a reasonable expectation of privacy in 1834 Lynfield Drive. *Commonwealth v. Torres*, supra at 104, 764 A.2d at 542. *See also, Commonwealth v. Enimpah*, 62 A.3d 1028 (Pa. Super. 2013) (the defendant bears the burden of proof to show a reasonable expectation of privacy in the place searched). Defendant cannot simultaneously contend (1) that he is not affiliated with 1834 Lynfield Drive and (2) that his constitutional rights were violated by a search of that residence.
