COMMONWEALTH of PENNSYLVANIA v. PETER MEDVE, Defendant

PCRA—Withdraw Plea—Plea Agreement—Sentencing—Manifest Injustice.

Defendant's PCRA petition was granted where the Deputy Attorney General argued in favor of a particular sentence at Defendant's sentencing, contrary to the terms of the plea agreement. While the statement of the DAG did not ultimately affect the sentence of the Court, the holding of Commonwealth v. Williams, 333 Pa. Super. 77, 481 A.2d 1230 (1984) required a finding that the DAG's breach of the plea agreement amounted to "manifest injustice" and entitled the Defendant to withdraw his plea. Defendant was permitted to withdraw his nolo contendere plea.

ORDER

AND NOW, this 28th day of May 2019, upon consideration of Defendant's petition for collateral relief pursuant to the Pennsylvania Post Conviction Relief Act, and the Commonwealth's response thereto, and following a hearing, it is hereby ORDERED that the Defendant's petition is GRANTED. This matter shall reconvene for further proceedings, at which Defendant may withdraw his *nolo contendere* plea, on June 27, 2019 at 1:00 p.m. in Courtroom No. 4.

STATEMENT OF REASONS

Defendant was charged herein with one count of sexual abuse of children by dissemination of child pornography—18 Pa. C.S. §6312(c); one count of criminal use of a communication facility—18 Pa. C.S. §7512(a); and 318 counts of sexual abuse of children by possession of child pornography—18 Pa. C.S. §6312(d). Defendant entered a *nolo contendere* plea on March 31, 2017 to eleven counts of possession of child pornography, acknowledging that the Commonwealth possessed sufficient information to prove that he possessed eleven videos of minors engaged in acts that included sexual penetration. Sentencing was deferred for the preparation of various evaluations to aid the Court in fashioning an appropriate sentence for this Defendant. On July 7, 2017, Defendant was sentenced to 42 months to 120 months on each of the eleven counts of possession of child pornography. The sentences on each of the eleven counts were run concurrently, for an aggregate sentence of 42 to 120 months. Following the imposition

of sentence, Defendant filed a post-sentence motion, contending that the "sentence imposed was an abuse of the Court's discretion [and] unduly excessive." That motion was denied on July 24, 2017. On August 15, 2017, Defendant filed a Notice of Appeal. On August 18, 2017, we directed Defendant to file a statement of the matters he complained of on appeal, and such a statement was filed on September 11, 2017, wherein a single issue was raised—Defendant claimed that his sentence "was unduly harsh and excessive, inconsistent with the Sentencing Code, and contrary to the fundamental norms underlying the sentencing process." We filed a memorandum opinion in response thereto on September 26, 2017. Ultimately, Defendant elected to forgo his direct appeal rights, seeking permission to withdraw his appeal on December 11, 2017. That permission was granted by the Superior Court by way of an Order dated January 16, 2018.

On February 26, 2018, Defendant filed a petition for collateral relief pursuant to the Pennsylvania Post Conviction Relief Act, 42 Pa. C.S. §9541 *et seq.* An amended petition was filed April 17, 2018. While an issueframing conference was scheduled for April 20, 2018, Defendant on that date made a request for additional discovery, and an evidentiary hearing was held on July 19, 2018 in connection with that request. The request was ultimately denied by Order dated August 14, 2018. On October 19, 2018, the issue-framing conference was held, at which it was determined that a hearing would be necessary. After a continuance request by the Defendant, that hearing took place on March 28, 2019. Briefs were ordered and timely filed by both parties.

In his petition, Defendant raises four claims that he believes entitle him to collateral relief: (1) the failure of his sentencing counsel to object to the Commonwealth's breach of the plea agreement; (2) the failure of his plea counsel to hire an appropriate expert to evaluate the evidence in preparation of a trial defense; (3) the failure of his plea counsel to litigate a motion to suppress evidence obtained pursuant to a warrant issued on the basis of stale evidence; and (4) the failure of his plea counsel to litigate a motion to suppress his coerced statements.

In order for a defendant to be granted relief on collateral review as a result of his prior counsel's ineffectiveness, a defendant must overcome the presumption of effectiveness, and prove the three elements of what is commonly known as the *Pierce* test, showing that (1) the underlying claim has arguable merit; (2) no reasonable basis existed for counsel's actions or failure to act; and (3) the defendant suffered prejudice as a result of counsel's error. *Commonwealth v. Pierce*, 515 Pa. 153, 527 A.2d 973 (1987).

In the first issue raised in his petition for collateral relief, Defendant contends that his sentencing counsel, Attorney Gregory Pagano, was ineffective insofar as he failed to object, or to advise Defendant that he could withdraw his plea, when the Commonwealth failed to honor its agreement not to take a position at sentencing on the kind or length of sentence imposed

by the Court. Defendant contends that, contrary to its agreement, the Commonwealth argued in favor of a particular sentence, where Deputy Attorney General Angela Raver requested a minimum sentence of incarceration in the standard guideline range, with a probationary tail. (N.T. 7/7/17, p. 34.)

For its part, the Commonwealth acknowledges that it agreed not to take a position on sentencing, but argues that the statements made by DAG Raver did not constitute argument in favor of a particular sentence, but rather were a reminder to the Court about the applicable sentencing guideline ranges. However, whereas the applicable sentencing guideline ranges had been discussed at length *in camera* and then placed on the record by the Court shortly prior to DAG Raver's statements, after it had been determined that the sentencing guideline forms previously prepared by Northampton County Adult Probation were inaccurate, we do not believe that her statements can be viewed in this light. (N.T. 7/7/17, pp. 8-9.) Moreover, in reading DAG Raver's statements, it is clear that she requested that Defendant receive a particular sentence *as a result of* his conduct and in consideration of the fact that certain charges were being withdrawn as part of the plea agreement. ("I also think incarceration is appropriate in this case considering the charge before the Court." *Id.* at 34.)

While the statements of DAG Raver at sentencing had no effect on the sentence imposed by this Court, as we would have imposed an identical sentence without her statements, we recognize that the absence of an effect on the Court does not negate the violation of the agreement, and that, had Defendant objected to the Commonwealth's remarks at sentencing, we would have been constrained to sustain that objection. Moreover, we believe that, had Defendant filed a direct appeal raising that violation, the Superior Court would have reversed Defendant's sentence and permitted him to withdraw his plea, consistent with *Commonwealth v. Williams*, 333 Pa. Super. 77, 481 A.2d 1230 (1984).

In *Williams*, the defendant entered into a guilty plea to certain charges, with an agreement by the Commonwealth to withdraw the remaining charges and to make no recommendation as to sentence. At Mr. Williams' sentencing, the prosecutor, after reciting certain of Mr. Williams' biographical information of which the court was already in possession, stated, "I believe the defendant should be sentenced to a period of incarceration for this very serious crime." *Id.* at 80, 481 A.2d at 1232. After the sentencing court's denial of a timely motion to withdraw the defendant's plea, the Superior Court concluded that the prosecutor's remarks amounted to a violation of the plea agreement, and that the violation, even if it were inadvertent, and even if it had no effect on the sentencing judge, "constitute[d] manifest injustice," entitling the defendant to withdraw his plea. *Id.* at 83, 481 A.2d at 1234. We believe this case clearly controls the matter now before us, and on this basis we find that Defendant has satisfied the first, "arguable merit," prong of the *Pierce* test.

We next turn to the second, "reasonable basis," prong of the Pierce test, which requires Defendant to prove that his prior counsel, Mr. Pagano, lacked a reasonable basis for failing to object to the Commonwealth's advocacy. In resolving this question, we must determine whether, in pursuing a particular course of action, "counsel made an informed choice, which at the time the decision was made reasonably could have been considered to advance and protect [the] defendant's interests." Commonwealth v. Dunbar, 503 Pa. 590, 596, 470 A.2d 74, 77 (1983). At the hearing on this matter, Mr. Pagano testified that he did not object to DAG Raver's comments, or advise Defendant that he could or should seek to withdraw his plea, because he did not find those comments to be objectionable. (N.T. 3/28/19, pp. 112-13.) Based upon our reading of Williams, we cannot concur in Mr. Pagano's assessment. Moreover, given that Mr. Pagano failed to perceive that there was an objection to be made to DAG Raver's remarks, we do not believe that we could find that his failure to make an objection was the result of a considered choice designed to advance Defendant's interests. Accordingly, Defendant has met his burden on this issue.

Finally, with respect to the third prong of the *Pierce* test, we find that Defendant has likewise met his burden on this issue. At the hearing in this matter, Defendant testified that he would have sought to withdraw his plea after DAG Raver's remarks at sentencing, had he been advised by Mr. Pagano that this was an option available to him. (N.T. 3/28/19, pp. 140-41.) Whereas we believe that *Williams* would have required us to grant Defendant's motion to withdraw his guilty plea had one been made during Mr. Pagano's representation, we believe that prejudice has been established, as "but for the errors and omissions of counsel, there is a reasonable probability that the outcome of the proceedings would have been different." *Commonwealth v. Kimball*, 555 Pa. 299, 312, 724 A.2d 326, 333 (1999).

We note that we have considered the question of whether Defendant has waived collateral review of this issue, because "an issue is waived if the petitioner could have raised it but failed to do so before trial, at trial, during unitary review, on appeal or in a prior state postconviction [sic] proceeding." 42 Pa. C.S. §9544(b). Having given the question of waiver thorough consideration, we believe this issue is not waived, despite Defendant's withdrawal of his direct appeal, as he has framed the issue as sentencing counsel's ineffectiveness in failing to preserve the matter for direct appeal. Commonwealth v. Grant, 572 Pa. 48, 67, 813 A.2d 726, 738 (2002) ("a claim raising trial counsel ineffectiveness will no longer be considered waived because new counsel on direct appeal did not raise a claim related to prior counsel's ineffectiveness."). See also, Commonwealth v. Martinez, 372 Pa. Super. 202, 539 A.2d 399 (1988) (noting that issue raised here was waived for collateral review where that defendant did not contend that sentencing counsel was ineffective for failing to preserve same for direct review).

Because we find that we must conclude that Defendant is entitled to withdraw his *nolo contendere* plea because of Attorney Pagano's ineffectiveness, the balance of the issues raised in his petition are now moot.

We note in closing, as did the Superior Court in *Williams*: "Of course, the charges previously [withdrawn] shall all be reinstated," and Defendant shall be subject to prosecution "to all the original charges." *Id.* at 84-85, 481 A.2d at 1234.
