COMMONWEALTH OF PENNSYLVANIA v. HECTOR M. CRUZ, JR.

Omnibus Motion—Motion To Dismiss—Pa.R.Crim.P. 600—Due Diligence

In the Court of Common Pleas of Northampton County, Pennsylvania, Criminal Division, No. 2005-1540.

Order of Court entered in favor of Defendant.

DESCRIPTION OF DECISION

Defendant filed an Omnibus Pretrial Motion in the nature of a motion to dismiss pursuant to Pa.R.Crim.P. 600(A)(3) and a petition to quash the motion to file the information without a preliminary hearing and to quash the criminal information.

Upon reviewing the evidence, this Court concluded that the Commonwealth did not meet its burden in proving it exercised due diligence in bringing defendant to trial within 365 days after the complaint was filed. In an attempt to locate Defendant, the officer did not use the information and knowledge he had regarding Defendant's known residence. Instead, the officer filed a Fugitive Notice. Therefore, this Court held that the Commonwealth lacked due diligence in bringing Defendant to trial and that the circumstances causing the delay in the commencement of trial were not beyond the Commonwealth's control. As a result, this Court granted Defendant's motion to dismiss.

EASTON AREA INDUSTRIAL LAND DEVELOPMENT, INC. v. TOWNSHIP OF FORKS BOARD OF SUPERVISORS

DESCRIPTION OF DECISION

This case was before the court following a remand to Appellee, in which the court directed Appellee to develop a more substantial record. Upon remand, Appellee Township conducted a hearing where two traffic studies were presented. Based on these studies, Appellee affirmed its earlier ruling, which limited Appellant's use of roads to access its subdivision. Appellant appealed this ruling, and the Court found in favor of Appellee. The Court affirmed Appellee's decision because the record supported the ruling and Appellee had acted within the bounds of the local Ordinance.

TOWNSHIP OF BUSHKILL v. JAMES R. LILLY AND BARBARA J. LILLY

DESCRIPTION OF DECISION

Previously, the Court entered an Order directing the Defendants to remove junk from their property. A hearing was held before a Master to determine if the Defendants had complied with the Order. Following the hearing, the Master issued a report, to which the Defendants filed exceptions. The Court denied all of the Defendants' exceptions, finding that the principles of res judicate and collateral estoppel applied. These principles prevented the Defendants from raising the issues that had been raised and decided in the prior proceeding.

DONALD WAYNE BLOUNT v. LORI ELLEN BLOUNT

Petition to Modify Custody

In the Court of Common Pleas of Northampton County, Pennsylvania, Civil Division—Law, No. CV 1992-5676.

DESCRIPTION OF DECISION

At the time the Petition was filed, the Child at issue was living with her Mother in Pennsylvania, with frequent visitations with her Father in California. Father petitioned the Court to modify the current custody arrangement for the Child, and grant him primary physical custody. Despite Father being an equally fit parent, the court held that the best interests of the child and the facts of this case called for denial of Father's Petition.

COMMONWEALTH OF PENNSYLVANIA v. JARVIS KENTRAL CURTIS

Omnibus Pre-Trial Motion to Suppress

DESCRIPTION OF DECISION

The Defendant filed an Omnibus Pre-Trial Motion, asking the Court to suppress the drugs found on him during a search of his person, and to dismiss the charges against him. The Court held that the police had illegally detained the Defendant by placing

him in custodial detention without reading him his *Miranda* warnings. Due to the illegal detention, the drugs found on the Defendant could only be used as evidence at trial if the Commonwealth proved that the Defendant voluntarily consented to the search and if the Commonwealth established a break in the causal chain between the illegal detention and the drugs. Based on the totality of the circumstances, the Court found that the Defendant's consent was coerced and not voluntary. Furthermore, the drugs would not have been discovered absent the illegal detention. Therefore, the drugs were suppressed. As a result, the Commonwealth could not make out a prima facie case against the Defendant, so the charges were dismissed.

COMMONWEALTH OF PENNSYLVANIA v. VINCENT FRANKLIN

Post Sentence Motion

DESCRIPTION OF DECISION

The Defendant filed a Post Sentence Motion, claiming that the Court erred at trial. The Defendant argued that his due process rights were violated when the Court allowed the Commonwealth to allege that the Defendant had committed sexual crimes against a minor on at least one occasion during a thirty-seven month period. The Court concluded that the Defendant's due process rights were not violated under the balancing test established in *Commonwealth v. Devlin*, 460 Pa. 508, 333 A.2d 888, specifically because the Defendant had engaged in a continuous, repeated course of criminal conduct against the minor over the thirty-seven month period.

The Defendant also argued that the crimes for which he was convicted should have merged and that he was given an improper sentence that deviated from the sentencing guidelines. The court upheld the Defendant's sentence because deviation from the guidelines was appropriate due to the fact that the Defendant showed no remorse and demonstrated the propensity to pass to others his sexually transmitted disease.

Finally, the Defendant claimed that his conviction should be reversed because the verdict was against the weight of the evidence or, in the alternative, the evidence was insufficient to sustain his conviction. The Court rejected both of these arguments, finding the evidence clearly supported the Defendant's conviction on all charges.

DESCRIPTION OF DECISION

The Defendant filed a Motion to Dismiss for a Violation of his Speedy Trial Rights under Pennsylvania Rule of Criminal Procedure 600. The Court found that the Defendant's Speedy Trial Rights were violated and dismissed the case. The Court held that, during a ten year period, the police did not make reasonable attempts to locate the Defendant, who was openly living in the local area. Furthermore, the police acted unreasonably by failing to enter the Defendant's name into either the NCIC or CLEAN databases. The court noted that the police could not justify their failure to use these databases on the basis that the Defendant had a common last name. The police had other information about the Defendant, including his social security, which would have made it reasonable to enter the Defendant's name into NCIC or CLEAN.

However, the Court found that the Agency failed to demonstrate by clear convincing evidence that Mother's parental rights should be terminated. Because Mother remained a viable resource for the children, the Agency's change in goal to adoption vas denied.
