DESCRIPTION OF DECISION

Defendant filed an Omnibus Pretrial Motion in the nature of a motion to dismiss and motion to suppress.

Officer Shupp observed Defendant making a right-hand turn to travel westbound. Defendant, in making said turn, crossed the center line and nearly struck the curb in the eastbound lane. Officer Shupp stopped Defendant, at which time he observed Defendant's eyes to be red, bloodshot and glassy and noticed an odor of alcohol emanating from the vehicle. Defendant failed the sobriety tests given to him and was arrested for Driving Under the Influence. The Court held that a police officer can stop a vehicle for violation of the Vehicle Code, *Commonwealth v. Sebek*, 716 A.2d 1266 (Pa. Super. 1998), and may further detain a defendant if there is reasonable cause for detention. *Commonwealth v. Zook*, 851 A.2d 178 (Pa. Super. 2004).

In doing so, the Court held that when considering the specificity of the paragraph in question, the paragraph must be read in context with all the other allegations in the complaint. *Yacoub v. Lehigh Valley Medical Associates, P.C.*, 805 A.2d 579, 589 (Pa. Super. 2002). The Court also held that when pleading agency, the Plaintiffs must, at a minimum, plead the identity of the agent by name or appropriate description and also set forth the agent's authority and how the conduct was within the scope of authority. *Rachlin v. Edmison*, 813 A.2d 862, 870 (Pa. Super. 2002). This Court granted Defendant's preliminary objection for a more specific pleading of agency, as Plaintiffs did not plead the requirements of an agency claim.
