JUDGE McFADDEN: Good morning, ladies and gentlemen. It is With deep sadness that this Court convenes today to reflect upon the lives and the work of our esteemed members who have passed away within the last year. As a Court, we are honored to have the families and friends of our deceased members with us for this Memorial Service.

At this time I will turn over the service to Judge Giordano.

JUDGE GIORDANO: Good morning, everyone. Good morning on behalf of the Bench of Northampton County. I'd like to welcome you all to today's Memorial Service and I'd like to extend a special welcome to the family and friends of the deceased. When we think of a Memorial Service we think of grief, we think of sorrow, we think of loss. Today we gather for the purpose of celebrating the careers of 2 men of the Northampton County Bar who passed away this year. I believe it is appropriate that we gather here in Courtroom Number 1, a room so rich in tradition, as I suspect both of our colleagues who are being honored here today once stood before this Bench and took their Oath of

while these men came from very different locations within this County and practiced in very different areas of the law, they both had in common a commitment to community and a sense that the practice of law was an honor and a profession not simply a means to earn a living.

At this juncture the Court recognizes Magisterial District Judge, Jacqueline Taschner, President of the Northampton County Bar Association.

MS. TASCHNER: Thank you. As President of the Bar Association, this is a bittersweet task for me. During the past year we have had to say goodbye to 2 members of our Bar Association, Pedro Boone and Norman Peil.

Now, as lawyers we work long hours often making personal sacrifices to promote the causes of our clients. Because of the unique challenges of our profession we develop strong bonds with our colleagues. And in a way, we become our own family. The Northampton County Bar is just that, an extended family whose

members are adversaries within these walls yet can walk through those doors and share a cup of coffee, a summer outing, a meal, a vacation. congratulate victories, share the joys of marriage and birth and other successes. And we often offer our support when a colleague suffers a personal or professional loss. This collegiate and sense of family is what brings us here today. We honor the memories of our associations with Norman Peil and Pedro Boone. we thank them for their dedication and their service to their families, our family, the Northampton County Bar, the profession and the community that they loved. It is bittersweet because Pedro and Norman are no longer with us to share their wisdom, their values, their passion for the law. We mourn them and we continue to mourn them. But today, as Judge Giordano stated, we are here to celebrate them, their lives, their personal and professional accomplishments. So as we pay tribute to our colleagues we also say goodbye and we say thank you.

I'm here today, as well, to talk about Pedro Boone. Pedro Boone was an only

child born to Lula and Lemuel Boone in the small farming community of Ahoskie, North Carolina. Pedro's humble roots marked his life; his story is best told in the words of his cousin, Beverly Hill Murray, who spoke fondly of him at his memorial service.

Pedro lost his father at a very early age, and his mother remarried and moved up into this area, up north. Pedro was sent down home to Ahoskie during the summers, spending time on his uncle's family farm.

As a teenager, he met and fell head-over-heels in love with Kathryn Grantham, his Kitty. Despite protests from both families, the teenagers married. As youngsters, they had 4 children; 3 daughters and a son. For Pedro, his responsibility to his family was his primary concern. He possessed innate entrepreneurial skills. He managed to own his own service station and a car dealership, Pioneer Motors, at an early age. His beautiful bride not only cared for the family, but she also had a successful catering business.

And Pedro and Kitty were partners in every sense of the word. Pedro would be a

bartender at Kitty's catering events and Kitty would work with Pedro in his automotive business.

Pedro and Kitty realized the importance of education. And both had an insatiable desire to continue the education which had been interrupted by their youthful romance and marriage. After being a businessman, after raising a family, Pedro obtained a BA from Moravian College, an MBA from the University of Southern Illinois and his JD from Temple University. Pedro, in fact, received his law degree in the same month as his daughter, Tricia. And that was an accomplishment. And they were both very proud of that.

Throughout his life, Pedro wore He was a financial consultant for many hats. and President of Venture Development; a real estate broker and President of Venture Development Properties: Syndicator and President of Hydroelectric Corporation; a securities broker and Corporate Secretary for the International Investor's Services of Abington, Pennsylvania. And he eventually established his

private practice as a wills and trust attorney here in Northampton County. He was licensed to practice law in both Pennsylvania and New Jersey.

Pedro's heritage was that of serving his community. His great grandfather, Lemuel Washington Boone, was an educator, clergyman and political activist, 1 of the most influential African Americans in North Carolina in the mid to late 19th Century. Pedro, too, loved his community and served it in various He was Secretary of the Advisory Board for the Salvation Army; Past President of the Torch Clubs International, and a member of the Pennsylvania Bar Association and the National Association of Security Dealers. Pedro succeeded in most everything he tried and believed that necessity was the mother of Pedro, with the help of his invention. stepfather, built his family's home from the ground up. He was an amateur photographer and this hobby became an avocation. He documented many, many family events. In fact, 2 short weeks before his death, Pedro attended the Boone Family Reunion in Greensboro, North Carolina.

It was an annual event that he helped organize 37 years ago.

Pedro loved life. He was eager to embrace new ideas, new friends, new cultures. He traveled to India, China and Egypt. He was planning a trip to Greece at the time of his death.

In summarizing the life that was Pedro Boone, Ms. Murray said, Pedro came from distinguished but humble beginnings. He overcame the obstacles he faced and with talent and determination, he seemed to have achieved everything he set out to accomplish, and then some. When he reached an age when many others would have been counting down the years to retirement, he was happily reinventing himself.

through his professional expertise and knowledge of law and finance. He took great pride in the accomplishments of his children and his grandchildren. Pedro's final bequest, that his body be entrusted to the Humanity Gifts Registry of the Commonwealth of Pennsylvania for medical education and research speaks volumes about his selflessness and his character.

For 85 years, Pedro L. Boone was a mover and shaker who would not be deterred by situation or circumstance. He took his obligations as a husband, father, attorney and friend very seriously.

On a personal level, I was saddened to learn of Pedro's death. I knew Pedro had been practicing law part-time when he passed away on July 30th and I was amazed that he was still practicing law at age 85. And then I look at Norman Seidel and I know he's still practicing law in his 90s. And that is quite an accomplishment. We'll miss seeing Pedro at our activities. More so, I'm going to miss the impish little grin, that twinkle in his eye when he tried to be the curmudgeon.

The time for mourning is past, today we celebrate his life, his dedication, his spirit. He met life's challenges head on with gusto and determination. I am honored to have been his colleague, his friend, his family.

Now I'm going to ask Norm Seidel to say a few words about Norman Peil.

MR. SEIDEL: May it please the Court, we are assembled in this historic

courtroom to honor the memory of a colleague, fellow advocate and good friend, Norman A. Peil, Jr, who left us on June 7th of this year.

Solely because of my age, I am not a stranger to this time honored tradition of the Bar Association. As a matter of fact, 2 of Norman's late colleagues, Gus Milides and Robertson Taylor, both much younger than I, for years would argue in my presence about which 1 of them would have the dubious honor of doing my eulogy. Unfortunately, I had the sad privilege of doing both of them.

For you, Elda Mathias Peil,
Norman's life mate, and Karen, Cindy, Chris and
Steve, and yes, even his brother and special
friend, Ray, this ceremony provides the Bar with
an opportunity to let you know the high esteem
in which Norman was held by his fellow lawyers.
Norman's reserved, low key demeanor did not lend
itself to his telling you on his own of his
sterling accomplishments in his chosen
profession.

when I came to the Bar, the County was governed by 3 county commissioners. The law required at least 1 be a member of the minority

party. Northampton County was then solidly Democratic. Norman Peil, Sr, often referred to as Nick, Norman's dad, was the perennial Republican elected every 4 years to serve in that office. The high regard in which he was held by the community at large and particularly by his political adversaries, augured well for the place his son, Norman Jr, would eventually take as a respected member of our Bar.

Norman was born on July 22, 1925, was graduated from Easton High School Class of '43 and received a Bachelor of Science in Economics at the Wharton School of the University of Pennsylvania in 1946. Completing what was a 4 year course in just 3 years at such a prestigious university gave early indication of Norman's industry, intensity and zeal in whatever he undertook. He then studied accounting, leading to his Pennsylvania CPA certification in 1948, and practiced that profession for a highly regarded center city Philadelphia accounting firm for 2 years, part of it with Peat Marwick & Mitchell. Yet he managed to attend law school and while working received his L.L.B, later a Juris Doctor degree

from Temple Law School in 1951. He was admitted to practice before the Pennsylvania Supreme Court that year and later admitted to practice in Northampton County, in this very courtroom.

On December 10th, 1962 he was admitted to practice before the United States Supreme Court. That admission was not a mere formality, for Norman was just 1 of possibly 2 possibly or 3 members of our Bar who would ever have the privilege of actually arguing a case before the highest Court in the land.

I got to know Norman when he was doing his then required clerkship for 1 of the County's eminent attorneys, Bernard M. Goodman.

It was not long thereafter that our Bar came to recognize his exceptional qualifications as a tax lawyer. His experience as a CPA and his work in the Office of Chief Counsel for the Internal Revenue Service in Newark, New Jersey, served him well in achieving this measure of expertise.

Because of his exceptional skill, he managed to attract as clients most of the then giant companies in the Valley, including Alpha Portland Cement Company and Weller

Electric Company General Supply Company, just to mention a few.

Over and above his professional qualifications, there were 2 virtues that struck you on your very first meeting with Norman Peil, integrity and competence.

Norman needed no Professional Code of Ethics to dictate his conduct as a professional. His personal ethics were far more stringent than those promulgated by any professional society. Norman Peil, in fact, exemplified the highest standard of professional ethics, standards which his fellow lawyers could seek to achieve. His colleagues might well have referred to him as quote, Mr. Integrity, end quote. In the parlance of the day he was called quote, a straight arrow, end quote. Few of us would measure up to the high standard Norman Peil had set for his own professional conduct.

In addition, most of us, including his secretary of 50 years, Mary Wing, knew Norman as the consummate workaholic. So much so that it became a standing joke among his colleagues that Norman had become a traffic hazard, reading tax cases and tax reports and

commentaries while he was crossing Center Square on his way to his office in the Alpha Building from his home in Phillipsburg, New Jersey.

I personally witnessed some close calls he had with traffic.

His studious attention to all nuances of the Internal Revenue Code and their interpretation made him a constant source of research for all of us just general practitioners not able on our own to fathom the labyrinth of the Federal Tax Law Code.

He did find time, however, to be a loving husband, father and grandfather. He enjoyed his annual family jaunts to Stone Harbor, New Jersey, where he did some part-time fishing. And I'm sure a full-time reading of the new amendments to and/or cases interpreting the U.S. Tax Code. He found time to take part as a member of the Kiwanis, the Pomfret Club, Friends of the state Theatre, St. Peters Lutheran Church on College Hill and St. John's Lutheran Church on 4th Street. He served as a particularly valued member of the Board of the Warren Hospital in New Jersey, serving as President of its Foundation as well as the Boards of the

Lafayette Ambassador Bank, Visiting Nurse Association and the Phillipsburg Free Public Library.

As busy as he was, he found time to teach accounting at Farliegh Dickinson
University and Lafayette College, form a law partnership with Michael Egan and later act as counsel to the firm of Funt, Dayton and Duckworth in Bethlehem.

Amidst all of his work, study and professional responsibility, he was always grateful for having had the opportunity to teach Sunday School in East Orange, New Jersey for it was there that he met his wife, Elda, who at the time was still a young Upsala College student whom he married on September 7th, 1957.

As his Pastor commented, Norman was a man of great faith and immense commitment to the church.

Norman and Elda traveled extensively, visiting 50 states and 10 Canadian provinces, including the Yukon Territory, managing, nevertheless, to spend some winters in Venice, Florida.

While an unrepentant New York

Yankees fan, he did find time to root for Philadelphia Athletics or Phillies, that is, when they weren't playing the Yankees.

His quiet, unassuming manner managed to mask the zeal with which he furthered the interests of his clients. I know from personal experience the high regard in which he was held by the Tax Court and the Federal District Court. In 1957, he successfully handled an estate tax matter on behalf of 1 of my clients. The acumen he exhibited in bypassing the Tax Court and convincing the Middle District Federal Court of the merits of his case made him immediately my quotes, go to, end quote, guy whenever I had a client who had an issue with the Internal Revenue Service.

Many of my colleagues soon followed suit.

There were 3 pillars to Norman's make up; family, church and profession. He managed each with 3 characteristics; modesty, integrity and competence.

His presence will be missed not only by his colleagues but by all who knew him.
