# C. Superior Court Session at the Northampton Community College

#### D. Retention Plebiscite

It was announced that the NCBA would be implementing a procedure, pursuant to the By-Laws of the Northampton County Bar Association, to conduct a referendum on the retention of the Honorable Emil A. Giordano, Judge of the Court of Common Pleas of Northampton County, and the Honorable Jack A. Panella, Judge of the Superior Court of Pennsylvania. Both Judges are up for retention this year. Secret ballots will be distributed to the members of the NCBA. The ballots will be accompanied by instructions concerning the procedures for submission of the secret ballot, and the date by which the ballot must be received. President Margle asked for participation by the members of the NCBA. The results will be distributed to the members of the NCBA, and to the Judges subject to retention.

## E. Black Heritage Month

An announcement was made concerning a request by Judge Jack Panella of the Superior Court of Pennsylvania for the NCBA to participate in a program conducted by the Girls/Boys Club of Easton, for Black Heritage month. The Board of Governors at a

It was reported that proposals and options were given to the NCBA by Steve Glickman with regard to the NCBA Building facility. Scomillio, Esq., to authorize the NCBA to spend up to \$12,000.00 to pursue the Glickman proposal and Option A. That MOTION was properly seconded, and approved by the membership in attendance at the meeting.

A plaque was displayed which was presented to the Young Lawyers' Division of the Northampton County Bar Association. That plaque recognized the NCBA and the Young Lawyers' Division as a someone special volunteer for the Volunteer Center's 2012 Holiday Hope Chest Program.
