COMMONWEALTH of PENNSYLVANIA, Plaintiff v. ALKIOHN DUNKINS, Defendant

Sufficiency of the Evidence—Conspiracy—Juror—Challenge to Verdict—Pa. R.E. 606—Post-Sentence Motion.

Defendant's post-sentence motion challenging the sufficiency and weight of the Commonwealth's evidence on the charge of conspiracy was denied where the circumstances of the object crime, a robbery, made clear that planning and forethought between the actors had taken place, there was sufficient evidence to point to Defendant as one of the actors, and the weight of the evidence did not require a result contrary to the guilty verdict. The Court also denied the Commonwealth's request to hold a hearing for the purpose of questioning a juror, where that juror had attempted to impeach the verdict by means of testimony regarding the conduct of deliberations but made no allegation that outside influence had come to bear upon the verdict. Such testimony may not be received by a court to impeach a verdict, pursuant to the Rules of Evidence.

ORDER

AND NOW, this 1st day of March 2019, upon consideration of Defendant Alkiohn Dunkins' Post-Sentence Motion, and the Commonwealth's response thereto, it is hereby ORDERED that the motion is DENIED, for the reasons set forth below.

STATEMENT OF REASONS

On September 5, 2018, Defendant Alkiohn Dunkins (Defendant) was convicted of Robbery—18 Pa. C.S. §3701(a)(1)(ii); Conspiracy to Commit Robbery—18 Pa. C.S. §903; Receiving Stolen Property—18 Pa. C.S. §3925(a); and Simple Assault—18 Pa. C.S. §2701(a)(1), in connection with an armed robbery that took place on February 2, 2017 on the campus of Moravian College in Bethlehem, Pennsylvania. On January 4, 2019, Defendant was sentenced to serve a total period of incarceration of 60-120 months, comprised of 36-72 months on the charge of Robbery, a consecutive 24-48 months on the charge of Conspiracy, and a concurrent 1-12 months for Simple Assault. No penalty was imposed for the charge of Receiving Stolen Property, as that crime merged with Robbery for sentencing purposes. On January 10, 2019, Defendant timely filed the within Post-Sentence Motion. While counsel initially requested a hearing, that request was withdrawn, and a briefing schedule was set by the Court. Both parties timely filed their respective briefs. Having reviewed the parties' briefs, and

the record in this matter, we have concluded that the Motion should be denied.

I. Sufficiency of the Evidence

In the first portion of his Post-Sentence Motion, Defendant contends that the Commonwealth presented insufficient evidence to support his conviction of the crime of Conspiracy to Commit Robbery—18 Pa. C.S. §903. We note that he does not challenge the sufficiency of the evidence presented by the Commonwealth with respect to the object crime, Robbery—18 Pa. C.S. §3701(a)(1)(ii).

A challenge to the sufficiency of the evidence asks this Court to consider "whether, viewing all the evidence admitted at trial in the light most favorable to the [Commonwealth as] verdict winner, there is sufficient evidence to enable to factfinder [sic] to find every element of the crime beyond a reasonable doubt." Commonwealth v. Heberling, 451 Pa. Super. 119, 122, 678 A.2d 794, 795 (1996). Notably, the "Commonwealth may sustain its burden of proving every element of the crime beyond a reasonable doubt by means of wholly circumstantial evidence." Commonwealth v. Valette, 531 Pa. 384, 388, 613 A.2d 548, 549 (1992). In order to prove the charge of Conspiracy beyond a reasonable doubt, the Commonwealth must present evidence to "demonstrate the formation of an illicit agreement, the attendant specific shared intent to promote or facilitate the object offense, and an overt act." Commonwealth v. Chambers, 188 A.3d 400, 410 (Pa. 2018). When evaluating a challenge to the sufficiency of the evidence to support this charge, we may not substitute our own judgment for that of the jury, and may only conclude that sufficient evidence to support the conviction was absent where the "evidence is so weak and inconclusive that as a matter of law no probability of fact may be drawn from the combined circumstances." Commonwealth v. Cassidy, 447 Pa. Super. 192, 195, 668 A.2d 1143, 1144 (1995). Having considered the record in this case, we find that the evidence presented by the Commonwealth in support of the Conspiracy charge is far from weak and inconclusive.

At trial, the Commonwealth presented *inter alia* the testimony of two witnesses, William Reilley and Greg Farina, who testified as follows about the robbery at issue. In the early morning hours of February 2, 2017, two individuals banged on Mr. Reilley and Mr. Farina's dorm room door, claiming to be campus safety officers. The men burst into the room wearing ski masks after Mr. Farina opened the door, demanding to know where "the weed" was. One man struck Mr. Farina in the face; the other man had a gun pointed at Mr. Reilley and told him not to scream. The man with the gun demanded keys to the footlocker under Mr. Reilley's bed. After he provided them, the man without the gun removed \$1,000 from the footlocker and sifted through the contents of Mr. Reilley's desk drawer, removing a jar of marijuana that he then handed to the man with the gun. The men

demanded to know if there was any other money in the room and then took some small bills that were lying on the desk. The man with the gun hit Mr. Reilley in the head, and the two men then left the room. (N.T. 9/4/18, pp. 31-38; N.T. 9/5/18, pp. 152-57.) In addition to this testimony, the Commonwealth presented the testimony of Colin Zarzecki, who related that Defendant visited his dorm room in the early morning hours of February 2, 2017, bragging that he had just participated in the robbery of a student in another dorm, during which exchange Defendant indicated that he had committed the robbery with another individual. (N.T. 9/5/18, pp. 102-105.)

Defendant argues in his Memorandum of Law in support of his Post-Sentence Motion that the "Commonwealth presented no evidence of an agreement between Mr. Dunkins and anyone else. There was no evidence presented as to who the other person may have been, what sort of agreement was made, or when said agreement was reached." Def. Memo, p. 4. We disagree. While the Commonwealth did not present any direct evidence with respect to the factors named by Defendant, the testimony of Mr. Reilley and Mr. Farina is strong circumstantial evidence of a conspiracy. While "[m]ere association with the perpetrators, mere presence at the scene, or mere knowledge of the crime is insufficient" to prove that a person was engaged in a conspiracy, what we have in this case is far more than a "mere" presence, knowledge, or association. Commonwealth v. Lambert, 795 A.2d 1010, 1016 (Pa. Super. 2002). To the contrary, the evidence presented established that Defendant and another male, both of whom were wearing ski masks, banged on the victims' dorm room door at approximately 2:00 a.m. on February 2, 2017, both gained entry to the dorm room after the door was opened by Mr. Farina, and both proceeded to act in concert to commit an armed robbery of the two victims. (N.T. 9/4/18, pp. 31-38; N.T. 9/5/18, pp. 152-57.) In order for a jury to believe that there was not a conspiracy between the two masked men to commit this robbery, the jury would have to believe that it was a mere coincidence that two men both arrived at the victims' dorm room at the same time, both wearing ski masks, and that these two strangers executed an armed robbery on the spot with no forethought, planning, or conspiring whatsoever.1 Such a conclusion would stretch the bounds of imagination beyond their breaking point. Accordingly, we find that there was sufficient evidence presented by the Commonwealth to support Defendant's conviction of Conspiracy. See e.g., Commonwealth v. Kidd, 251 Pa. Super. 140, 380 A.2d 416 (1977).

II. Weight of the Evidence

Next, Defendant contends that the verdict of guilty on all charges is against the weight of the evidence presented, and that he must be granted a new trial.

¹ We note that proof of the identity of the unnamed coconspirator is not required. *Commonwealth v. Brown*, 229 Pa. Super. 67, 323 A.2d 845 (1974).

A motion for a new trial based on a claim that the verdict is against the weight of the evidence is addressed to the discretion of the trial court. ... A new trial should not be granted because of a mere conflict in the testimony or because the judge on the same facts would have arrived at a different conclusion. ... Rather, the role of the trial judge is to determine that notwithstanding all the facts, certain facts are so clearly of greater weight that to ignore them or to give them equal weight ... would deny justice. ... It has often been stated that a new trial should be awarded when the jury's verdict is so contrary to the evidence as to shock one's sense of justice and the award of a new trial is imperative so that right may be given another opportunity to prevail. ...

Commonwealth v. Clay, 619 Pa. 423, 431-32, 64 A.3d 1049, 1054-55 (2013) (internal citations and quotations omitted).

Having heard all of the evidence at trial and having reviewed same in consideration of the within motion, we cannot conclude that the weight of the evidence demands that Defendant be granted a new trial. In addition to the testimony of Mr. Reilley, Mr. Farina, and Mr. Zarzecki, as noted above, the Commonwealth presented the testimony of Christopher Laird, director of systems engineering at Moravian College, who testified that an analysis of the Moravian College Wi-Fi network records revealed that, during the one-hour time frame surrounding the robbery—1:30 a.m. to 2:30 a.m. on February 2, 2017—the unique Wi-Fi network username of Defendant was connected to a short range Wi-Fi access point in the dormitory of the victims. (N.T. 9/5/18, pp. 215-19.) On cross-examination, defense counsel elicited further testimony from Mr. Laird indicating that a device utilizing Defendant's Moravian Wi-Fi user account was connected to various Wi-Fi network access points in and around the Wilhelm and Hassler dorms during the robbery time frame in such a manner demonstrating travel from the Wilhelm dorm, where Defendant lived, to the Hassler dorm, where the robbery occurred, and then back to Wilhelm. Id. at 220. While there was no direct evidence presented that Defendant was actually in possession of the device that was connected to these Wi-Fi access points at the relevant times, it is entirely reasonable that the jury would conclude that he was in possession of that device. Considering this evidence together with all other evidence presented in the trial, we find that nothing about the verdict in this matter shocked the Court's conscience or sense of justice. To the contrary, the evidence fully supports the conclusion that Defendant was engaged in the armed robbery at issue. We believe that the verdict of the jury comported with the evidence presented at trial and that the verdict should stand.

III. Motion for Extraordinary Relief

In the third portion of his motion, Defendant contends that we erred in denying his Motion to Suppress and Motion for Extraordinary Relief. Those motions were previously denied by Orders of Court dated April 26, 2018 and December 7, 2018, respectively, wherein we set forth our reasoning for those dispositions. We believe that those previous Orders fully address our reasoning therefor and thus incorporate same by reference in denying this portion of Defendant's motion.

IV. Request to Interview Juror

Finally, Defendant contends that we erred in denying his request for a hearing at which he would call a juror to testify. More specifically, at sentencing Defendant indicated that he wished to question a specific juror regarding her post-trial "accusations [to Court Administration] that several jurors were forced or bullied into entering a verdict of guilt despite believing Mr. Dunkins' innocence." Def.'s Memo, p. 8. An *in camera* conference regarding this juror's report to Court Administration had been held on October 19, 2018, wherein the Court informed counsel that the juror "believed and initially voted that Mr. Dunkins was not guilty," but that "the foreman continued to yell and belittle them, telling them that Mr. Dunkins is guilty," and that after a period of deadlock she and three other jurors "were so worn down and finally voted guilty." (N.C. 10/19/18, pp. 5-6.) We note that the record will reflect that the total deliberation period was approximately five hours.

As Defendant accurately recites in his memorandum of law, a "juror may testify about whether (A) prejudicial information not of record and beyond common knowledge and experience was improperly brought to the jury's attention; or (B) an *outside* influence was improperly brought to bear on any juror." Pa. R.E. 606(b)(2) (emphasis added). The concerns raised by the juror in this case in her report to Court Administration did not pertain to any outside influence such as information not of record or interference by a third party with the deliberations, but to the behavior of a fellow juror in the deliberation room. Testimony regarding same is prohibited by the Rules of Evidence. "During an inquiry into the validity of a verdict, a juror may not testify about any statement made or incident that occurred during the jury's deliberations; the effect of anything on that juror's or another juror's deliberations; or any juror's mental processes concerning the verdict. The court may not receive a juror's affidavit or evidence of a juror's statement on these matters." Pa. R.E. 606(b)(1) (emphasis added). "[A]fter a verdict is recorded and the jury discharged, a juror may not impeach the verdict by his or her own testimony." Commonwealth v. Williams, 279 Pa. Super. 28, 31, 420 A.2d 727, 729 (1980). "[W]e cannot accept the statement

² In his motion and brief, Defendant states that he requested an opportunity to "interview" the juror. However, at sentencing, Defendant's request was "that the Court should issue a hearing" to take the testimony of the juror, not for counsel to interview the juror individually. (N.T. 1/4/19, p. 38.)

of jurors as to what transpired in the jury room as to the propriety or impropriety of a juror's conduct. ... To do so, would destroy the security of all verdicts and go far toward weakening the efficacy of trial by jury, so well grounded in our system of jurisprudence. Jurors cannot impeach their own verdict. Their deliberations are secret and their inviolability must be closely guarded." *Id.* (internal citations omitted).

Whereas the juror at issue did not indicate that any *outside* influence had come to bear on the deliberations or verdict, it would have been inappropriate to grant Defendant's request for a hearing. The hearing would have served no purpose where the juror would be precluded from giving any testimony that could support a challenge to the verdict. "Defendants are prohibited from using post-verdict statements of jurors as means to contest their conviction in a post-conviction proceeding." *Commonwealth v. Eichinger*, 631 Pa. 138, 180, 108 A.3d 821, 846 (2014).
