Civil Procedure—Landlord Tenant—Section 8 Housing Choice Voucher— Notice to Ouit.

Plaintiff filed a complaint for possession of a rental property and unpaid rent for an apartment rental in Bethlehem, Pennsylvania. At a hearing before Magistrate District Judge Richard H. Yetter, III, judgment was entered in favor of Plaintiff. Defendant filed a "Notice of Appeal from Magisterial District Judgment" and Preliminary Objections to Plaintiff's First Amended Complaint arguing that the court lacked subject matter jurisdiction over the matter due to Plaintiff's failure to serve Defendant with a proper and timely notice to quit. Plaintiff served Defendant with a notice to quit after filing their landlord tenant action with the magisterial district court. Therefore neither the magisterial district court nor the court of common pleas had jurisdiction to hear the matter. Accordingly, Plaintiff's complaint was dismissed.

Order of the Court entered on January 24, 2024 by Beltrami, J.

#### **OPINION**

This case is before the court on Defendant's Preliminary Objections to Plaintiff's First Amended Complaint ("POs"), which were filed on September 26, 2023. Briefs have been submitted, and the POs are ready for disposition.

On July 18, 2023, Defendant ("Tenant") initiated this landlord/tenant action by filing a "Notice of Appeal from Magisterial District Judgment." On August 4, 2023, Plaintiff ("Landlord") filed a Complaint seeking money damages for unpaid rent and possession of the leased premises. On August 23, 2023, Tenant filed Preliminary Objections to the Complaint arguing, *inter alia*, that Landlord did not provide her with a proper notice to quit, thereby depriving this court of jurisdiction.

On September 12, 2023, Landlord filed a First Amended Complaint, as of course, pursuant to Pennsylvania Rule of Civil Procedure 1028(c)(1). In its First Amended Complaint, Landlord alleges the following facts. On August 29, 2019, Landlord and Tenant entered into a lease agreement for premises located at 2132 Freemansburg Avenue, #2, Bethlehem, Northampton County. (Am. Compl. ¶10, Ex. A.) The lease was for a one-year term starting on September 1, 2019, and is governed by the Section 8 Housing Choice Voucher Program. (*Id.* ¶11, Ex. A.) On September 1, 2020, the lease became a periodic tenancy and continued on a month-to-month basis. (*Id.* ¶12.) Tenant breached the lease agreement by failing to pay rent in August 2021. (*Id.* ¶¶ 20-21.) Landlord provided a Notice to Quit to Tenant on

September 11, 2023. (*Id.* ¶30, Ex. D.) In Count I of its Amended Complaint, Landlord seeks unpaid rent. In Count II, Landlord seeks possession.

On September 26, 2023, Tenant filed the instant POs. Tenant's first objection is made pursuant to Pennsylvania Rule of Civil Procedure 1028(a)(1) and asserts a "lack of jurisdiction over the subject matter of the action." Pa. R.Civ.P. 1028(a)(1).1 "Subject matter jurisdiction is defined as 'the power of the court to hear cases of the class to which the case before the court belongs, that is, to enter into inquiry, whether or not the court may ultimately grant the relief requested." *Harley v. HealthSpark Found.*, 265 A.3d 674, 687 (Pa. Super. 2021) (quoting *Lowenschuss v. Lowenschuss*, 579 A.2d 377, 380 n.2 (Pa. Super. 1990)).

A proper and timely notice to quit is a prerequisite to filing an eviction action at a magisterial district court pursuant to the Landlord Tenant Act of 1951. See Fraport Pittsburgh, Inc. v. Allegheny Cnty. Airport Auth., 296 A.3d 9, 18-20 (Pa. Super. 2023). The failure to give a proper and timely notice to quit deprives a magisterial district court of jurisdiction to enter judgment in favor of a landlord. Fulton Terrace Ltd. P'ship v. Riley, 4 D. & C.4th 149, 154 (Ct. of C.P. of Fulton Cnty. 1989). When a magisterial district court does not have jurisdiction because of an untimely or improper notice to quit, any judgment it renders is defective. Id. In an appeal from such a defective judgment, this court does not have jurisdiction to enter judgment in favor of the landlord and, therefore, lacks subject matter jurisdiction. Id.

In this case, the parties' lease is governed by the Section 8 Housing Choice Voucher Program. (Am. Compl. Ex. A.) Pursuant to that program, the parties' lease states that "[a]t or before the beginning of a court action to evict [Tenant], [Landlord] must give [Tenant] a notice that specifies the grounds for termination of the tenancy." (Am. Compl., Part A ¶11(1).) By the averments in its own Amended Complaint, Plaintiff served Tenant with a notice to quit on September 11, 2023. However, a review of Tenant's Notice of Appeal to this court reveals that this action was filed in the magisterial district court on June 21, 2023. Because a notice to quit was not served on Tenant *prior* to the filing of the eviction action, the magisterial district court did not have jurisdiction to hear the matter or render judgment. Thus, this court does not have jurisdiction to review that defective judgment, and Plaintiff's First Amended Complaint must be dismissed.<sup>2</sup>

WHEREFORE, the court enters the following:

<sup>&</sup>lt;sup>1</sup> Ordinarily, a preliminary objection based on a court's lack of subject matter jurisdiction cannot be determined by facts of record and may require a hearing. *See* Pa. R.Civ.P. 1028(c) (2) note. However, in this case, Tenant's POs were endorsed with a notice to plead, Landlord filed a response, and the relevant facts are contained within the First Amended Complaint and the court's file.

#### ORDER

AND NOW, this 24th of January, 2024, Defendant's Preliminary Objections to Plaintiff's First Amended Complaint are hereby SUSTAINED. Plaintiff's First Amended Complaint is hereby DISMISSED, with prejudice.
